## 3.1 SRPI.23.004 - Richmond Hill Office Development and Village Revitalization Community Improvement Plan Program Update (City File CIP-22-0002)

Megan Cobbold, Senior Planner – Policy, Planning and Infrastructure, made a presentation regarding an update to the Richmond Hill Office Development and Village Revitalization Community Improvement Plan (CIP). She reviewed background information of the program, and provided an overview of the three grant programs offered by the CIP: Façade, Landscaping and Signage Improvement Grant; Building Renovation Grant; and Tax Increment Equivalent Grant (TIEG). She further provided an update on the CIP that was approved in principle, promotional campaigns, and feedback received on consultations held in the Fall of 2022. M. Cobbold highlighted additional proposed updates to the CIP, next steps of the grant program, and reviewed staff's recommendations as outlined in staff report SRPI.23.004.

There were no applications submitted from the public to appear as an electronic delegation, and there were no members of the public who responded to the Chair's invitation to address Council on this matter.
