#### 3. Scheduled Business

### 3.1 Education and Training session regarding the Richmond Hill Centre:

Darlene Joslin, City Manager, provided introductory remarks regarding the Richmond Hill Centre, highlighted the benefits and team working on the project, and advised that the purpose of the meeting was to provide background information on the project to assist Council in future decision making.

### 3.1.1 Richmond Hill Centre Project Overview and Context

Anthony Ierullo, Director of Richmond Hill Centre and Economic Development, provided an overview of key components of the Richmond Hill Centre (RHC) project, including the Yonge North Subway Extension, the role of the RHC team and structure, the City's actions in support of the project, and key milestones and Council considerations.

### 3.1.2 Yonge North Subway Extension Update

Daniel Olding, Senior Manager, Richmond Hill Centre Project, provided details on the Yonge North Subway Extension project including the project scope, anticipated benefits, Metrolinx's ongoing public engagement, stakeholder outreach activities and planned Community Support Program, project milestones and timeline.

### 3.1.3 Richmond Hill Centre Secondary Plan Update

Clement Chong, Project Manager, Planning Policy, provided introductory remarks with respect to the Richmond Hill Centre Secondary Plan, noted the ongoing public engagement and importance of stakeholders in the development of the draft Secondary Plan, and introduced Leigh McGrath, Urban Strategies Inc., lead consultant on the project.

Leigh McGrath, Urban Strategies Inc. reviewed the RHC Secondary Plan process timeline, vision and development principles, character areas and land use, built form, height and density, and mobility and transportation. She further reviewed details on parks and open spaces, community services and facilities, housing, servicing, stormwater, inputs informing Secondary Plan finalization, and next steps.

### 3.1.4 Richmond Hill Centre Development Activity Update

Deborah Giannetta, Manager, Development, Richmond Hill Centre, introduced the Richmond Hill Centre Development Review team and their role, reviewed the active development applications in RHC, and provided details on the implementation of the High Tech Transit Oriented Community.

Mayor West provided closing remarks regarding the Richmond Hill Centre, noting the scale, importance, and commitment of the City to the project, and thanked staff, the consulting team, and members of Council for their engagement.
