

# The Corporation of the City of Richmond Hill

## By-Law 17-23

A By-law to Amend Chapter 1116 of the City of Richmond Hill Municipal Code, being By-law 402-89, as amended, relating to Parking Regulation

**WHEREAS** on November 6<sup>th</sup>, 1989, the Corporation of the City of Richmond Hill (the “City” enacted by by-law No. 402-89 that regulates the parking of motor vehicles on public highways and other property (“Parking Regulation By-law”).

**Now Therefore The Council of The Corporation of The City Of Richmond Hill Enacts as Follows:**

1. That Article 1 – Interpretation in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by deleting the following text:

**Pedestrian crosswalk - defined**

“pedestrian crosswalk” means any portion of a highway designated by by-law of a municipality, at an intersection or elsewhere distinctly indicated for pedestrian crossing by signs on the highway and by lines or other markings on the surface of the highway as prescribed by regulation.

2. That Article 1 – Interpretation in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by inserting the following text, in alpha-numerical order:

**Pedestrian crossover - defined**

“pedestrian crossover” means any portion of a highway at an intersection or elsewhere distinctly indicated for pedestrian crossing by signs on the highway and lines or other markings on the surface of the highway.

**Pedestrian crosswalk - defined**

“pedestrian crosswalk” means any portion of a highway at an intersection or elsewhere distinctly indicated for pedestrian crossing by signs on the highway or by lines or other markings on the surface of the highway.

3. That Section 1116.3.7 – Parking – Stopping – Prohibited – Specified Places Signs in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by deleting the following text:

(q) park in a cul-de-sac; and

(r) on a highway within 30 metres (100 feet) of a roundabout or traffic circle.

4. That Section 1116.3.7 – Parking – Stopping – Prohibited – Specified Places Signs in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by inserting the following text:

(q) park in a cul-de-sac;

(r) on a highway within 30 metres (100 feet) of a roundabout or traffic circle; and

(s) on a highway within 30 metres (100 feet) of a pedestrian crossover.
