## By-Law 20-23

A By-law to Amend Chapter 1135 of the City of Richmond Hill Municipal Code,  
relating to U-turn Prohibitions

**Whereas** Council at its meeting of February 8, 2023 adopted the recommendation in SRPI.23.016 to amend U-turn prohibitions at the road segments noted below

**Now Therefore The Council of The Corporation of The City Of Richmond Hill Enacts as Follows:**

That, Article 1 – General Provisions in Chapter 1135 of the City of Richmond Hill’s Municipal Code be amended by inserting the following, in alpha-numerical order:

**Bernard Avenue**

No driver or operator of a vehicle upon that part of Bernard Avenue from Price Street to Viewmark Drive shall turn the vehicle so as to proceed in the opposite direction.

**Crosby Avenue**

No driver or operator of a vehicle upon that part of Crosby Avenue from Neal Drive to 200 metres west of Osiris Drive shall turn the vehicle so as to proceed in the opposite direction.

**Farmstead Road**

No driver or operator of a vehicle upon that part of Farmstead Road from Shell Court to Shirley Drive shall turn the vehicle so as to proceed in the opposite direction.

**Painted Rock Avenue**

No driver or operator of a vehicle upon that part of Painted Rock Avenue from Shaftsbury Avenue to 150 metres north of Shaftsbury Avenue shall turn the vehicle so as to proceed in the opposite direction.

**Redstone Road**

No driver or operator of a vehicle upon that part of Redstone Road from Toporowski Road to Princenton Avenue shall turn the vehicle so as to proceed in the opposite direction.

**Shaftsbury Avenue**

No driver or operator of a vehicle upon that part of Shaftsbury Avenue from Casa Grande Street to Larratt Lane shall turn the vehicle so as to proceed in the opposite direction.

**Shirley Drive**

No driver or operator of a vehicle upon that part of Shirley Drive from Romance Drive to Holly Drive shall turn the vehicle so as to proceed in the opposite direction.

**Stave Crescent**

No driver or operator of a vehicle upon that part of Stave Crescent from 60 metres north of Waterhouse Way to Tollbar Court shall turn the vehicle so as to proceed in the opposite direction.

**Waterhouse Way**

No driver or operator of a vehicle upon that part of Waterhouse Way from Larratt Lane to Stave Crescent shall turn the vehicle so as to proceed in the opposite direction.
