1. Call to Order/National Anthem

The Mayor called the meeting to order at 9:31 a.m.

Mayor West transferred the Chair to Regional and Local Councillor Chan between:

- 10:33 a.m. and 10:40 a.m. during consideration of Item 14.1.

2. Public Forum (not to exceed 15 minutes)

There were no members of the public who addressed Council during the Public Forum.

3. Council Announcements

Regional and Local Councillor Chan thanked his colleagues and those who attended his New Year's Levee a couple of weeks ago, and noted that it was well attended and the City was ready to begin the Richmond Hill 150th anniversary celebrations.

Regional and Local Councillor Chan extended his condolences on behalf of himself and the community to those who were killed in the devastating earthquake in Turkey and Syria, and called upon members of the community to donate to an organization or help those affected if able to do so.

Mayor West echoed the sentiments of Regional and Local Councillor Chan regarding the tragic devastation caused by the earthquake and extended his thoughts and prayers to the people in Turkey and Syria.

Mayor West recognized that February was Black History Month and advised of the number of interesting events scheduled to take place throughout the month, and noted his attendance at the Town of Aurora's Black History Gala where the Honourable Jean Augustine, the first Black Canadian Member of Parliament, was a keynote speaker.

Mayor West acknowledged a number of significant dates in the month of February including one of the most auspicious times in Hinduism on February 18 where the god Shiva is worshiped and honoured; the season of Lent which starts on February 27 and ends on April 8, noting that he is hosting his annual Maple Syrup Festival on April 1; and Pink Shirt day on February 22 where Members of Council stand together in support of anti-bullying initiatives, and encouraged everyone to wear pink on that day.

Mayor West gave a shout out to everyone who has volunteered in the last 54 years to make the annual Richmond Hill Winter Carnival a success, and extended his thanks to the volunteers and Co-Chairs who helped organize the event this past weekend which was another big success.

12. Delegations**12.1 Kathleen Wynne, on behalf of The Women of Ontario say No, regarding the Member Motion submitted by Mayor West regarding Stopping Harassment and Abuse by Local Leaders Act, 2022 - (refer to Item 14.1)**

Kathleen Wynne, on behalf of The Women of Ontario say No, addressed Council regarding the Member Motion submitted by Mayor West regarding *The Stopping Harassment and Abuse by Local Leaders Act, 2022*. She provided background information on the issue and its importance, explained why the Bill was introduced, and provided an overview of the three primary components to the Bill as detailed in her correspondence distributed as Item 13.9. K. Wynne requested that Council support the Member Motion put forward by Mayor West, seconded by Councillor Davidson, that would endorse the Private Member's Bill introduced in the Ontario Legislature by MPP Stephen Blais.

12.2 Daniel Freiheit, 800-120 Eglinton Avenue East, Toronto - regarding the 2023 Draft Capital Budget and 9 Year Forecast - (refer to Item 13.1.1 and Proposed By-law 9-23)

Daniel Freiheit, 800-120 Eglinton Avenue East, Toronto, addressed Council regarding the 2023 Draft Capital Budget and 9 Year Forecast. He discussed the importance of promoting an equitable and inclusive workforce in a post-pandemic environment, and addressed investment priorities within the City of Richmond Hill's Capital Budget Forecast, questioning how that vision could be achieved when there were vaccine requirements in place for employees and new applicants to the City. D. Freiheit made suggestions as to where the municipality could invest its capital budget dollars and requested that the vaccine mandate be revoked.

12.3 Lincoln Lo, Malone Given Parsons Ltd., regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road - (refer to Item 13.2)

Lincoln Lo, Malone Given Parsons Ltd., agent for the applicant, addressed Council regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road. He advised that they were in support of the staff recommendations in SRPI.23.001, and that they have had a number of productive meetings with staff on how the proposal could be refined and revised to address the concerns identified in the report. L. Lo noted that they have also had constructive meetings with the Region of York, that there was opportunity for a different housing type on these lands that would bring benefit to the community, and that they appreciated the opportunity for continued discussions with staff for a potential resolution.

12.4 Feng Xiao (Sean), 53 Bawden Drive, regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road - (refer to Item 13.2)

Sean Xiao, 53 Bawden Drive, addressed Council regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road. He advised of his concerns with the proposed development because of the density, and the impact it would have on area traffic and community safety. S. Xiao questioned what benefit this development would bring to the community and advised that the area residents did not think it was a good project.

12.5 Su Eng Tan, 18 Bawden Drive, regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road - (refer to Item 13.2)

Su Eng Tan, 18 Bawden Drive, addressed Council regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road. She advised that she shared the same concerns as the previous delegate with the proposed development because of the density and impact it would have on area traffic, and noted that in her opinion, investing in transit for the area was not a viable solution. S. Tan further expressed her

concerns with the shadows that would result from the proposed height of the development as it would result in the current residents having less sunlight to enjoy.

12.6 Saeid Bokharaie, 107 Gerden Drive, regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road - (refer to Item 13.2)

Saeid Bokharaie, 107 Gerden Drive, submitted an application to appear as a delegation to address Council on this matter but was not in attendance.

12.7 Yidi Huang, 109 Bawden Drive, regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road - (refer to Item 13.2)

Yidi Huang, 109 Bawden Drive, addressed Council regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road. She advised of her concerns with the proposed development because of the height and density in comparison to the existing neighbourhood, and noted that there were already a number of new developments in the area that would be adding to the population. Y. Huang further advised of her concerns with the impact the proposed development would have on area traffic, and the lack of infrastructure in place to support the additional density.

12.8 Meng Zhang, 58 Hilts Drive, regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road - (refer to Item 13.2)

Meng Zhang, 58 Hilts Drive, addressed Council regarding the proposed Official Plan Amendment and Zoning By-law Amendment Applications submitted by Leslie Elgin Developments Inc. for 0 John Birchall Road. He advised that when he purchased his home, it was in a low density residential area and questioned how the proposed development could be considered for the subject lands. M. Zhang noted that he was in agreement with the previous delegates who expressed concerns with the impact the proposed development would have on area traffic, the new developments in the area that were already adding to the population, and the impact on community safety and security.
