Geoff Green, 297 Church Street South, provided a brief history of the development proposal prior to its resubmission, which included an increase to the Floor Space Index (FSI). He provided examples of existing developments that in his opinion were dense, and compared their respective FSI's to that of the proposed development to illustrate that it was double the density. G. Green urged Council to enforce the Official Plan and to vigorously defend its opposition to the application all the way to the Ontario Land Tribunal if required.
