#### 6. Scheduled Business

## 6.1 SRPI.22.092 - Review of the Cultural Heritage Value of 6 Greywacke Street (formerly 630 King Road) - City File D12-07232

Committee members discussed the situation of having to repeal the bylaw that designated 6 Greywacke Street under Part IV of the *Ontario Heritage Act* and subsequent demolition of the John Love House, and the impact this would have on the cultural heritage value of the property as well as the neighbourhood.

That Heritage Richmond Hill recommends to Council:

a) That staff report SRPI.22.092 be received;

b) That the property located at 6 Greywacke Street (formerly known as 630 King Road) no longer has cultural heritage value or interest;

c) That a by-law be passed to repeal By-law 95-13, amended by By-law 66-18, which designates 6 Greywacke Street (formerly known as 630 King Road) under Part IV of the *Ontario Heritage Act*.

d) That the Clerk:

- i. Serve a copy of the repealing by-law on the owner of 6 Greywacke Street (formerly known as 630 King Road);
- ii. Publish notice of the repealing by-law in a newspaper having general circulation in the municipality;
- iii. Cause the repealing by-law to be registered against the property;
- iv. Serve a copy of the registered repealing by-law on the Ontario Heritage Trust; and,
- v. Delete any reference to 6 Greywacke Street (formerly 630 King Road) from the municipal heritage register.

# 6.2 SRPI.22.104 - Review of the Cultural Heritage Value of 1621 Major Mackenzie Drive East - City File D12-07323

A general inquiry was made as a result of the approved development of this land being under a Minister's Zoning Order in terms of how these types of situations are addressed, and how it would impact a property that had heritage value. Committee members and staff discussed this scenario as it would have applied to the subject lands and the David Hislop House if the owner hadn't requested to demolish it.

Discussion took place regarding information in the staff report specific to the owner providing a plan that identified the ways in which the David Hislop House would be commemorated and how that process would unfold, including what municipal mechanisms were in place to ensure that the commemoration would occur.

c) That a by-law be passed to repeal By-law 143-97, amended by By-law 68-06, which designates 1621 Major Mackenzie Drive East (also known as 1577-1621 Major Mackenzie Drive East) under Part IV of the *Ontario Heritage Act*,

d) That the Clerk:

- Serve a copy of the repealing by-law on the owner of 1621 Major Mackenzie Drive East (also known as 1577-1621 Major Mackenzie Drive East);
- ii. Publish notice of the repealing by-law in a newspaper having general circulation in the municipality;
- iii. Cause the repealing by-law to be registered against the property;
- iv. Serve a copy of the registered repealing by-law on the Ontario Heritage Trust; and,
- v. Delete any reference to 1621 Major Mackenzie Drive East (also known as 1577-1621 Major Mackenzie Drive East) from the municipal heritage register.

## 6.3 Draft Proposal regarding Promoting Heritage Preservation in Richmond Hill dated July 2022 - Discussion Item submitted by Doris Dumais

Doris Dumais, Heritage Richmond Hill Committee member, provided introductory remarks regarding the work that was done by the Promotion and Marketing Sub-Committee, and made a presentation to report back on Committee Development and Heritage Promotion.

D. Dumais discussed the importance of developing the Heritage Committee and highlighted ways in which this could be done beginning immediately with the orientation of the Committee, followed by ongoing learning opportunities throughout the term. She then highlighted ways in with the municipality and the Heritage Committee could preserve heritage including:

- Develop a strategy for Heritage Promotion;
- Focus on public education and encouraging Heritage Site preservation via a virtual museum;
- Cultural Heritage Planning site and social media to be leveraged;
- Collaboration with partners to enhance promotion efforts;
- Resources for public and heritage site owners;
- Review of current grant program;
- Communication Strategy; and
- Outreach Activities.

Members thanked the Promotion and Marketing Sub-Committee for their work and efforts, and acknowledged the great ideas that were presented regarding Committee Development and Heritage Promotion. A thorough and detailed discussion ensued regarding the various ideas that were presented, such as having a Heritage Promotion Strategy and Communication Strategy, and how these ideas could be implemented for the next term of the Committee. # 6.4 Roadmap to Addressing Demolition by Neglect in Richmond Hill -Presentation by Dan Kelly

Dan Kelly, Heritage Richmond Hill Committee Member, made a presentation to the Committee regarding a Roadmap to Addressing Demolition by Neglect in Richmond Hill. He noted that the purpose of the presentation was to circle back to the number of discussions that the Committee has had over the years regarding demolition by neglect, and that tonight's presentation was to make recommendations regarding specific actions that could be taken by the new Committee during the next term.

D. Kelly reviewed the state of the heritage inventory, addressing the trend since 2008 where there has been a reduction in the number of designated properties, listed properties and City owned properties, and advised of his predicted outcome if the trend were to continue. He highlighted major influences that contributed to and impacted the heritage inventory including current and future legislation at both the provincial and municipal levels, as well as the economic environment, and addressed what could be done to manage the heritage inventory and protect vacant cultural heritage properties so that the Committee could carry out their mandate effectively and provide valuable advice to Council. D. Kelly noted that the City had an opportunity to establish principles and policies that would impact the direction taken when protecting cultural heritage, and outlined action items that could be taken including the establishment of a HRH Vacant Properties of Cultural Heritage Significance Sub-Committee, as further detailed in his presentation included as Item 6.4 on the agenda.

Committee members thanked D. Kelly for the presentation regarding a Roadmap to Addressing Demolition by Neglect in Richmond Hill. A detailed discussion ensued regarding the role of municipal heritage committees and the framework for which they and municipal staff work within regarding heritage matters. Moved by: Councillor Cilevitz

a) That the presentation by Dan Kelly, Heritage Richmond Hill Committee Member, regarding a Roadmap to Addressing Demolition by Neglect in Richmond Hill, be received.
