## **Background:**

Each year, organizations request permission to hold special occasion permits at various outdoor park locations. The Alcohol and Gaming Commission of Ontario requires a motion from Council approving the request in order for the groups to obtain a liquor license. All groups are required to follow the terms of the City of Richmond Hill Municipal Alcohol Policy and abide by all regulations stipulated by the Alcohol and Gaming Commission of Ontario.

### Financial/Staffing/Other Implications:

All special occasion permit holders pay \$300 per event in accordance with the approved Tariff of Fees By-Law (By-law No. 83-22). Revenue is deposited into Cost Centre 1133310, Account 436200.

# Relationship to Council's Strategic Priorities 2020-2022:

Enforcement of the Municipal Alcohol Policy and ensuring that special occasion permits are in compliance with the rules and regulations of the Alcohol and Gaming Commission of Ontario aligns with Council's strategic priority of a strong sense of belonging specifically by promoting the use of parks and public spaces as places for people to assemble and connect.
