1. Call to Order

The Mayor called the meeting to order at 10:00 a.m.

2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of

Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

4.1 Camile Garzon, Margaret Bahen Hospice and Doane House Hospice, regarding the Hike for Hospice fundraising event

Camile Garzon, Manager of Fund Development, Margaret Bahen Hospice and Doane House Hospice, shared information related to the end of life, grief and bereavement services that they provide to residents of Richmond Hill and York Region, noting that that rely heavily on the community to assist with operational costs to run their programs. She highlighted the annual Hike for Hospice fundraising event that brings families together to walk in honour or memory of their loved ones, and advised that this year's Hike is scheduled on May 13th at Fairy Lake Park in Newmarket. C. Garzon requested consideration by Members of Council to share the information related to the Hike for Hospice event through their social media to spread the word throughout the community.

13.1 Presentation by Mayor West to the Toronto Six Women's Professional Hockey Team and General Manager Angela James in recognition of winning the Isobel Cup

Mayor West made a presentation to the Toronto Six Women's Professional Hockey Team in recognition of winning the Isobel Cup on March 27, 2023. He highlighted the historic overtime win versus the Minnesota Whitecaps making the Toronto Six the first Canadian team in Premier Hockey Federation history to win the top trophy, and acknowledged the impact that the team has had on women's hockey and young female athletes. Mayor West introduced Angela James, General Manager, Mark Joslin, Assistant Coach, Sammy Jo Small, President, and Carly Jackson, goalie, and on behalf of the City of Richmond Hill extended congratulations to the team and presented those in attendance with a Certificate of Acknowledgement for being the Isobel Cup 2023 champions.

13.2 Presentation by Tracey Steele, Commissioner of Community Services, to Mayor West and Members of Council of the Municipality of the Year Award and Top 100 Festivals and Events in Ontario awarded by Festivals and Events Ontario (FEO)

Tracey Steele, Commissioner of Community Services, made a presentation to Mayor West and Members of Council of two awards that the City of Richmond Hill received at the Festivals and Events Ontario (FEO) Annual Conference held in March 2023 in Niagara Falls. She provided background information on the FEO and its role in helping its members produce unique and quality festivals and events through professional development, networking and promotions; and highlighted the FEO's website that lists the festivals and events happening throughout the province. She advised that the City of Richmond Hill was the recipient of the prestigious Municipality of the Year Award in the category of municipality with a population of 150,000 or more, and was also the recipient of the Top 100 Festivals and Events in Ontario for the City's Ribfest and Merry Marketplace events. T. Steele acknowledged the staff from the Recreation and Culture and Public Works Operations Divisions that contributed to the City's success, and presented the awards to Mayor West and Members of Council.
