Leigh McGrath, Urban Strategies Inc., was also in attendance in Council Chambers.

1. Call to Order

The Chair called the meeting to order at 10:00 a.m.

2. Council Announcements

Regional and Local Councillor Chan acknowledged that the coronation of King Charles III will take place on Saturday, May 6, and that Queen's Park will be hosting a celebration to mark the occasion.

Regional and Local Councillor Chan acknowledged that it was Mental Health Week, and noted the importance of listening to people's stories and showing support of mental health.

Regional and Local Councillor Chan acknowledged that it was Youth Week.

Regional and Local Councillor Chan noted that Richmond Hill was an inclusive and diverse community, and advised of a number of events being celebrated in May which included Armenian Heritage Month, Asian Heritage Month, Jewish Heritage Month, Dutch Heritage Month, and South Asian Heritage Month.

Mayor West acknowledged the 54th Annual Professional Municipal Clerk's Week, and advised that it was a time of celebration and reflection on the importance of the Clerk's Office. He recognized the work of the City Clerk, Deputy City Clerk, Council/Committee Coordinators and all those that worked in the Clerk's Office for their professionalism and support of Council and the Community.

Mayor West remarked on his history as a fan of the Toronto Maple Leafs, expressed his support and excitement, and wished the team all the best.

9. Presentations

- 9.1 Presentation by Anthony Ierullo, Director, Economic Development and Richmond Hill Centre and Leigh McGrath, Urban Strategies Inc.,**

regarding the Richmond Hill Centre Secondary Plan - (refer to Item 11.8)

Anthony Ierullo, Director, Economic Development and Richmond Hill Center, provided a brief history of the Richmond Hill Centre (RHC) Secondary Plan, and remarked on the significant public consultation that had taken place. He advised that the RHC Secondary Plan was intended to support the community and Council's vision for Richmond Hill Centre while achieving the necessary conformity to provincial policies.

Leigh McGrath, Urban Strategies Inc., commented on the importance of RHC as a key component of the City's urban structure, and reviewed the RHC Secondary Plan study timeline, finalization process, and components that framed the policies of the Secondary Plan which included:

- Vision and Development Principles
- Character Areas and Land Use
- Built Form Height and Density
- Mobility and Transportation
- Parks and Open Spaces
- Community Services and Facilities
- Implementation

L. McGrath noted that the draft Secondary Plan will include policies for transition areas, gateway sites, housing, and servicing stormwater, and concluded by outlining next steps for the RHC Secondary Plan.

10. Delegations

10.1 Delegations received regarding the Richmond Hill Centre Secondary Plan - (refer to Item 11.8)

David Crowley, 43 Greenbelt Crescent, shared his belief that the latest vision of the Richmond Hill Centre had abandoned its original goals and objectives of being a transit-oriented employment and activity destination, as further detailed in his correspondence submitted as Agenda Item 11.11. He shared his opinion that the probability of taking transit varied

with trip destination and vehicle access, and provided various statistics on commuting behaviours. He concluded by advising that in his opinion the updated plan would not work in transportation terms.

John Li, 206 Brookside Road, on behalf of the Richmond Hill Umbrella Residents Group, commented on the job-to-population ratio, and shared his opinion that the Richmond Hill Centre (RHC) Secondary Plan should strive to offset the damage caused by the Provincial Enhanced Minister Zoning Order, rather than exacerbate it. He shared his belief that the city was a “sleepy town”, and that the residents paid the consequences by paying the highest property taxes among comparable cities. He contrasted the job-to-resident ratio of the Union Station Area to the RHC to illustrate its shortcomings, and noted that the area would, in his opinion, become another St. James Town.

Ian Andres, Goodmans LLP, on behalf of Metroview Developments (Garden) Inc. (Metroview), provided a brief history of the development applications submitted by Metroview, noting that they remained under appeal with the Ontario Land Tribunal. He shared his opinion that the proposed Richmond Hill Secondary Plan included inappropriate density limits for the West of Yonge Character Area, and that the policies regarding neighbourhood transition and impact had been modified to become more rigid. I. Andres requested that Council remove the maximum density imposed on Schedule 2, and that modifications be made to polices on transition and angular planes, as was further detailed in his correspondence submitted as Agenda Item 11.11.
