

# The Corporation of the City of Richmond Hill

## By-Law 69-23

A By-law to amend By-law 69-16 of the City of Richmond Hill

Whereas on February 11, 2019, Council of the Corporation of the City of Richmond Hill (“Council”) enacted an amendment to By-law 69-16 that established an Administrative Monetary Penalty System (“AMPS”) for parking infractions, to expand AMPS so that it may also apply to promote compliance with any by-law passed pursuant to the *Municipal Act, 2001*;

And Whereas on June 14, 2023 Council of the City adopted the recommendations of Staff Report SRCS.23.16 to amend By-law 194-05, being Municipal Code Chapter 875, Refreshment Vehicles (the "Refreshment Vehicle By-law") and to add such By-law as a designated By-law to the Administrative Penalty By-law 69-16 so that the Refreshment Vehicle By-law may be enforced using AMPS.

**Now Therefore The Council of The Corporation of The City Of Richmond Hill Enacts As Follows:**

1. That By-law 69-16 of the Corporation of the City of Richmond Hill, as amended, be further amended by adding Table 9 attached to this By-law no. 69-23;
2. Except as herein provided and as required to give effect to the amendments in this By-law 69-23, the provisions of By-law 69-16 continue in full force and effect without amendment.
