Pursuant to the *Planning Act* s. 17 and s. 26:

McConaghy Seniors' Centre, 10100 Yonge St., Richmond Hill to provide the public with information on the four above noted proposed Official Plan Amendments. A **Council Public Meeting**, pursuant to Section 26 (3) of the *Planning Act*, is scheduled for **Tuesday, June 20, 2023, at 7:30 p.m.** to notify the public and receive comments on the proposed Official Plan Amendments. This meeting will be held in the **Council Chambers of the Municipal Offices**, 225 East Beaver Creek Road. ### Making a delegation at the Council Public Meeting:

There is the option of attending in person or electronically by video conference or by phone. Any person who wishes to speak to Council on these Official Plan Amendments must pre-register with the Office of the Clerk by 12 p.m. the day before the meeting. **Official Plan Appeal:** If a person or public body would otherwise have an ability to appeal the decision of the Approval Authority to the Ontario Land Tribunal (OLT), but the person or public body does not make oral submissions at the public meeting or make written submissions to the **City of Richmond Hill** before the proposed Official Plan Amendments are adopted, the person or public body is not entitled to appeal the decision of City Council to the Ontario Land Tribunal (OLT), and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

**Notice of Collection:** Personal information is collected under the authority of the *Planning Act*, R.S.O. 1990, c. P.13; and may be contained in an appendix of a staff report, published in the meeting agenda, delegation list, and/or the minute of the public meeting, and made part of the public record. The City collects this information in order to make informed decision on the relevant issues, and to notify interested parties of Council's decision. It may also be used to serve notice of an Ontario Land Tribunal hearing. The name, address, and other information contained in the submitted letter will be available to the public, unless the individual expressly requests the City to remove their personal information.
