1. Call to Order

The Mayor called the meeting to order at 10:00 a.m.

2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

3. National Anthem

The National Anthem was played.

4. Public Forum (not to exceed 15 minutes)

Julia Vasiliev, 99 Merton Street, addressed Council regarding a soccer field in her neighbourhood that was not being used and inquired about the process to have it repurposed into either a tennis court or basketball court so that the community could make better use of the space.

5. Council Announcements

Councillor Cilevitz thanked the residents who attended the Ward 5 Civic Engagement Committee (W5CEC) meeting last night at the Richmond Hill Central Library where the important issue of municipal by-laws were discussed, and extended her appreciation to the staff who were in attendance to make the presentation and to Chair Pat Pollock for all the work she has done for the W5CEC. Councillor Cilevitz advised that the York Pride Parade was being held on Saturday, June 17th in Newmarket and extended an invitation to everyone to attend to show their Richmond Hill and York Region pride.

Councillor Shiu advised that his Traffic Safety Seminar was being held this evening at the Main Municipal Office and would be attended by a York Regional Police Officer to discuss the enforcement of various driving regulations, as well as a guest speaker who was a traffic engineer who would address the benefits and drawbacks of various traffic calming measures, and extended an invitation for all to attend.

Regional and Local Councillor DiPaola advised residents that this Saturday, June 17th there was a community event at Lake Wilcox and reminded residents that they were able to register one vehicle for free for the season to ensure they have a parking spot for the event, and extended an invitation to everyone to attend.

Councillor Cui highlighted the Ward 4 Multicultural Heritage Gala that was held last Saturday at the Elgin West Community Centre noting that it was very well attended, and extended his thanks to Members of Council, the MPP and MP, as well as all of the residents who attended and for their support. Councillor Cui advised that this Saturday, June 17th the Mon Sheong Foundation was hosting their charity walk at the Richmond Green Park and noted everyone was welcome to attend, and further advised of an awards ceremony he would be in attendance at on Friday, June 23rd and extended an invitation to all to attend if they were available.

Councillor Thompson advised of the success of his Safety Symposium held last Thursday night at the Elgin Barrow Area noting that the event was very well attended, and extended his thanks to those who participated as well as to Deputy Mayor Chan and Mayor West for attending.

Mayor West acknowledged the many Councillor organized events that have been held in the community and thanked his colleagues for their efforts and contributions to the community. Mayor West advised that there was a Pride flag raising ceremony held last week at the Main Municipal Office and that the Pride flag was now flying proudly at 225 East Beaver Creek Road, and noted that he

was looking forward to participating in the Pride Parade being held in Newmarket on the weekend.

Stephen Collins, Program Sponsor, Yonge North Subway Extension, made a presentation to Council to provide a Project Update on the Yonge North Subway Extension, and introduced Rajesh Khetarpal, Vice President, Community Engagement (905 region); Chris Spencer, Vice President, Subway Project Delivery - Yonge North Subway Extension; and Renee Afoom-Boateng, Senior Manager, Third Party Adjacent Works - Subways, from Metrolinx who were in attendance to help answer any questions that may arise from the presentation.

S. Collins provided a detailed overview of the Project and reviewed recent milestones that included early work on the Finch Station, release of the Advance Tunnel Request for Qualifications (RFQ), ongoing utility relocations, and Transit Corridor Lands (TCLs) Designation and associated notifications. He reviewed property requirements including property acquisition and negotiation, progress to date, and next steps for the Project. R. Khetarpal provided an overview of the community engagement and communications activities, and advised of the various sources of information available regarding the Project on the internet and

social media. S. Collins concluded the presentation by thanking the Mayor and Members of Council for allowing them to present, and noted that they were available to answer any questions.
