6. Scheduled Business

- 6.1 Affordable Housing Strategy Update Priority Actions Undertaken To Date, Implications of the *More Homes Built Faster Act* (Bill 23), and Next Steps
 - Presentation by Chun Chu, Senior Planner Policy, and Sybelle von Kursell, Manager, Policy, Planning and Infrastructure

Kelvin Kwan, Commissioner of Planning and Infrastructure, provided introductory remarks regarding the Affordable Housing Strategy and Action Plan noting that a lot had changed since the last meeting in May of 2022 and that staff were looking forward to working with the Committee and hearing their comments regarding this significant issue.

Maria Flores, Director, Policy, introduced herself as well as Sybelle von Kursell, Manager, Policy, and Chun Chu, Senior Planner - Policy, from the Policy Planning Division who were working on this initiative and would be presenting to the Committee the Affordable Housing Strategy, Status Update on the Action Plan, at today's meeting.

Chun Chu, Senior Planner - Policy, noted the progress made to date on the implementation of the Affordable Housing Strategy and provided a detailed status update on the Action Plan highlighting completed, ongoing and in progress action items. She advised that the Handbook for Developing Affordable Housing had been updated, which was one of the action items, and that the Handbook contained updated affordable thresholds for rental and ownership housing and added new information about the Federal funding programs.

Sybelle von Kursell, Manager, Policy, addressed the impact of the *More Homes Built Faster Act* (Bill 23) on the Affordable Housing Strategy and Action Plan and reviewed legislative, regulatory, policy and other changes. She advised of the impact of Federal, Provincial and Regional programs on the Strategy and Action Plan, and noted actions that were awaiting conclusion based on the initiatives by other levels of government.

C. Chu concluded the presentation by providing a detailed overview of the action items that were underway, advised of the recommendation to receive the memorandum and presentation and refer all comments back to staff, and noted that the next meeting of the Committee was scheduled on July 4, 2023.

Committee members extended their thanks to staff for the extensive presentation and discussed the amended fees and reductions within the *Development Charges Act*, the impact on affordable housing, and the timeframe associated with Development Charges (DC's) on title; whether there would be a breakdown of the financial tools and incentives within the Community Improvement Plan (CIP) for home ownership and rental housing; goals and drawbacks of inclusionary zoning; and the requirement for a Peer Review of the Housing Needs Assessment, what that would entail and who would undertake the Peer Review.

Further discussion took place regarding what mechanisms would be put in place to maintain and ensure the affordability and price of a purchased housing unit long term and when the ownership was being transferred; updating and aligning the definition of "affordable" and potential implications of doing so; how Airbnb's would be addressed as an affordable housing option; what incentives were being put in place to build affordable housing; the purpose of conducting a Land Inventory within the municipality; the amendment to the *Planning Act* to permit additional residential units "as of right" and how that would support affordable housing; clarification on what the Community Benefits Charge Strategy entailed; and what partnerships were being considered.
