

Background:

On March 6, 2006, the owner of the subject lands (Stonecourt Construction Inc.) entered into a Site Plan Agreement with the then Town of Richmond Hill (City File D06-05058) to facilitate the construction of a 16,229 square metre (174,690 square feet) supermarket (Loblaw Companies Limited) and associated amenities on the subject lands. The agreement was registered on title on April 6, 2006 as Instrument Number YR800552. The owner has advised that due to various unforeseen circumstances and market changes, the development was never constructed and will not be pursued. Accordingly, the purpose of this report is to seek Council's direction with regard to the request from the land owner to deregister the existing Site Plan Agreement registered on title of the subject lands.

Summary Analysis:

Site Location and Adjacent Uses

The subject lands are located on the east side of Yonge Street, north of Crosby Avenue (refer to Map 1). The lands are currently vacant and abut Yonge Street to the west, existing commercial and industrial uses to the north and vacant lands to the east and south.

Owner's Request

The owner of the subject lands has requested that the City deregister the existing Site Plan Agreement (City File D06-05058) for the subject lands, as the owner would no longer like to proceed with construction of the approved proposed supermarket on its land holdings. In this regard, the owner is seeking Council's approval to enter into a Termination Agreement with the City to deregister the Site Plan agreement on title of the lands.

Planning Analysis

Planning staff has reviewed the request from the owner of the subject lands to deregister the existing Site Plan Agreement registered on their land holdings and have no objections to said request on the basis that City staff has confirmed that the development as contemplated by the agreement has not been constructed. In this regard, staff recommends that Council authorize the execution of a Termination Agreement between the owner of the lands and the City.

Financial/Staffing/Other Implications:

The recommendations of this report do not have any financial, staffing or other implications.
