

## The Corporation of the City of Richmond Hill

### By-Law 112-23

A By-law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being by-law 402-89, as amended, relating to parking regulation.

**WHEREAS** on November 6<sup>th</sup>, 1989, the Corporation of the City of Richmond Hill (the “City” enacted by by-law No. 402-89 that regulates the parking of motor vehicles on public highways and other property (“Parking Regulation By-law”).

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF RICHMOND HILL ENACTS AS FOLLOWS:**

1. That Schedule ‘A’ – Parking Prohibited – Signs – Displayed in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by inserting the following rows in alphabetical order:

Arten Avenue	South	Creekview Avenue to Regent Street	Anytime
Arten Avenue	North	Creekview Avenue to 30m West of the Arten/Creekview Avenue intersection	Anytime
Coco Avenue	North	Holly Drive to Shirley Drive	Anytime
Coons Road	North	Cynthia Crescent/ Grovepark Street and Yonge Street	Anytime
Coons Road	Both	Yonge St to 30m West of Yonge St	Anytime
Copperstone Crescent	South and West	Angelica Avenue to Frank Endean Road	Anytime
Creekview Avenue	East	Elgin Mills Road to Arten Avenue	Anytime
Creekview Avenue	West	Arten Avenue to 30m north of the Arten/Creekview Avenue intersection	Anytime
Dietzman Court	East	Augustine Avenue to the cul-de-sac opening [5 Dietzman Court]	Anytime
Holly Drive	South and West	Shirley Drive, to 9m north of the intersection of Holly Drive and Venture Avenue	Anytime
Holly Drive	East	9m South of the intersection of Holly Drive and Venture Avenue, to the cul-de-sac opening [110 Holly Drive]	Anytime
John Birchall Road	Both	Elgin Mills Road to Leslie Road	Anytime
Long Hill Drive	South and West	19 <sup>th</sup> Avenue to Post Oak Drive	Anytime
Napanee Street	East	Walter Sinclair St [N] to Walter Sinclair St [S]	Anytime
Venture Street	South	Holly Drive to Shirley Drive	Anytime
