G. Li provided background information and reviewed in detail the 2024 Budget Process and Strong Mayor Powers, Economic Scan and New Legislative Impacts, Budget Fundamentals, and the 2024 Draft Budget. She concluded the 2024 budget workshop by outlining next steps in the process which included the release of the Budget Book on November 8th, a series of Budget Committee of the Whole meetings each with specific items being brought forward for consideration, and the Mayor tabling the budget at the December 13th Council meeting.
