#### 1. Call to Order

The Mayor called the meeting to order at 10:00 a.m.

### 2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

#### 3. National Anthem

The National Anthem was played.

#### 4. Public Forum (not to exceed 15 minutes)

The following member of the public addressed Council during the Public Forum:

- 4.1 Samantha Fung, Kenisha Ahuja and Lauren Hui, Music For Every Child, reviewed their charity's mission, highlighted awards received, benefits to helping children with developmental disabilities, community engagements they participated in, and requested Council's assistance to expand their organizations work in Richmond Hill.
- 4.2 John Li, 206 Brookside Road, regarding Suggestions for Improving Municipal Operations, withdrew his request to address Council.

#### 5. Council Announcements

Councillor Cilevitz extended congratulations to the representatives from Music For Every Child, acknowledged the work they do, and noted she looked forward to contacting them.

Councillor Cilevitz advised that the Ward 5 Civic Committee meeting was being held on November 16<sup>th</sup> at the Central Public Library from 7 p.m. to 9 p.m., noted the topic of discussion was personal safety, that members of York Region Police would be making a presentation, and extended an invitation for everyone to attend.

Councillor Liu acknowledged the presentation from Music For Every Child and extended congratulations to the organization for their work.

Councillor Liu advised of the successful annual Ward 3 food drive event that was held on October 28<sup>th</sup>, and extended thanks to staff, volunteers and residents who generously donated to the Richmond Hill Community Food Bank.

Councillor Shiu extended congratulations to Music For Every Child organization for the work they do.

Councillor Shiu extended thanks to all participants at Saturday's "Young Mayor Workshop", advised of the successful event, and noted he looked forward to continuing more civic workshops in the future.

Regional and Local Councillor Chan extended thanks to Music For Every Child for their presentation, and advised that he scanned the QR code from their presentation and was able to view their Instagram account.

Regional and Local Councillor Chan advised that he attended the Business Improvement Area (BIA) Annual General Meeting last week, acknowledged Council Members in attendance, and noted he was pleased to see the progress of local merchants.

Regional and Local Councillor Chan advised that on November 4<sup>th</sup> he attended the first indoor Richmond Hill Pickleball Club tournament held at Rouge Woods Community Centre, acknowledged Members of Council who also attended, and remarked on the sport's popularity and inclusiveness.

Councillor Thompson advised that the month of November was CPR Month and that he was partnering with St. John Ambulance and Richmond Hill Board of Trade to offer a free CPR lesson to 150 people to help celebrate Richmond Hill's 150<sup>th</sup> anniversary. He advised that the event was being held on November 25<sup>th</sup>, at Richvale Community Centre for two hours, that he looked forward to receiving

registrations, and that more information was available on his social media as well as the St. John Ambulance website.

Councillor Davidson advised of the successful Break the Silence Step in My Shoes Walk in support of Yellow Brick House that was held on November 5<sup>th</sup>, shared her take-aways, and encouraged everyone to check out Yellow Brick House and support them.

Mayor West announced that today was Indigenous Veterans Day.

Mayor West advised that the annual Remembrance Day Parade was being held on November 11<sup>th</sup> at 10 a.m., starting at Yonge Street and ending at the Cenotaph located at M.L. McConaghy Seniors' Centre, and encouraged everyone to join the event.

Mayor West extended congratulations to Tyra Rosnuck, a 22-year old Richmond Hill resident and third year phycology student at the University of Guelph, for being crowned the 2023 Miss Tourism World Canada, noting she would represent our country and community very well.

Mayor West acknowledged the Council Members that participated at the Break the Silence Step in My Shoes Walk in support of Yellow Brick House, noted the event raised over \$118,000, and highlighted the important services provided by the organization.

Mayor West extended appreciation to Members of Council who hosted events and raised food and donations for the Richmond Hill Community Food Bank. He advised of his recent visit to the food bank and shared their constant struggle to supply food they needed for the community.

Mayor West advised of his virtual attendance at Councillor Shiu's "Young Mayor Workshop" on Saturday, and extended congratulations for a successful event.

Mayor West announced that he was hosting "I Love Richmond Hill" photo contest on November 15<sup>th</sup> from 6:30 p.m. to 8:30 p.m., at the Richmond Hill Centre for the Performing Arts, noted the entries received exceeded their expectations, that mini-workshops were available throughout the evening, and encouraged everyone to attend the event.

Councillor Cui advised of the successful Ward 4 food bank event and extended his thanks to residents for their generous donations.

Councillor Cui advised that he received many streetlight complaints, noted the City had a streetlight backlog, and asked residents to be patient and assured them that streetlights would be repaired as soon as possible.

Councillor Cui provided an update on the Neighbourhood Watch Program, noting engagement with York Region Police would commence soon to validate their findings and next steps to either install neighbourhood signs or other programs.

Councillor Cui advised that in 2023 46 women died as a result of domestic violence, and that York Region would be working with Yellow Brick House to launch an education program for students in grades 6 to 12 in the coming weeks.

# 13.1 Presentation by Maria Flores, Director, Policy Planning, regarding Richmond Hill's Nature Canada Bird Friendly City Certification

Maria Flores, Director, Policy Planning, made a presentation to Council regarding Richmond Hill's Nature Canada Bird Friendly City Certification. She reviewed Council's directive in March 2023 to proclaim World Migratory Bird Day, advised of Nature Canada's development of a bird-friendly certification standard, and acknowledged that the City received Entry Level status as a Bird Friendly Certified City in recognition of their

commitment in supporting and protecting bird populations. M. Flores recognized the Bird Team and City staff in attendance, as well as the Sustainability Team who collaboratively prepared the City for this designation. M. Flores, on behalf of Nature Canada, presented a Certificate to Mayor West and Members of Council for the City of Richmond Hill's designation as a Bird Friendly City.

Mayor West, on behalf of Council, extended his appreciation to everyone who helped make a difference and improving the environment in the City of Richmond Hill.

Mahdi Moradi, on behalf of the Downtown Richmond Hill Property Owners Group, addressed Council regarding the Richmond Hill Official Plan Amendment 18.6 (Village Local Centre). He advised that they were pleased with Council trying to enhance the downtown core, as the area had declined over the past years. M. Moradi displayed a map that outlined approximately 60 private property owners along Yonge Street who were interested in working with City staff to redevelop the village core area, and requested Council for additional time to discuss their concerns with staff, as detailed in their written submission included as Agenda Item 15.9.

Mark Yarranton, KLM Planning, on behalf of the Major Mackenzie landowners group for lands at 52, 58, 60, 66, 74 and 76 Major Mackenzie Drive West, addressed Council regarding the Richmond Hill Official Plan Amendment 18.6 (Village Local Centre). He shared his opinion with staff's response contained in the Memorandum from Commissioner Kwan, dated November 8, 2023, regarding their proposed modifications they were seeking for the subject lands. He stated that it was their belief that their approach was reasonable, it did not prejudice the future outcomes of landuse permissions, and that it satisfied the requirements of the *Planning Act*, Provincial Policy and Growth Plan, and the Region's Official Plan, and would ensure the development was appropriate. M. Yarranton requested Council amend recommendation b) to Staff Report SRPBS.23.028 to include their four proposed modifications or defer the matter to work through an appropriate solution with staff.
