

The Corporation of the City of Richmond Hill

By-Law 112-23

A By-law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being by-law 402-89, as amended, relating to parking regulation.

WHEREAS on November 6th, 1989, the Corporation of the City of Richmond Hill (the “City” enacted by by-law No. 402-89 that regulates the parking of motor vehicles on public highways and other property (“Parking Regulation By-law”).

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF RICHMOND HILL ENACTS AS FOLLOWS:

1. That Schedule ‘A’ – Parking Prohibited – Signs – Displayed in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by inserting the following rows in alphabetical order:
