#### 4.1 SRCS.23.26 - South Richvale Greenway Winter Trail Maintenance

#### 4.3 SRCFS.23.052 - 2024 Draft Operating Budget

Darlene Joslin, City Manager, thanked Gigi Li, Director, Financial Services and Treasurer, and her team for their efforts in assembling the budget package, and recognized the Commissioners, senior management and all staff for their work towards achieving the City's goals, as well as Mayor West and Regional and Local Councillor DiPaola for their guidance and leadership through the process.

D. Joslin acknowledged the challenges facing the community and the budget's emphasis on supporting the City's economic vitality with investments in infrastructure and service delivery areas. She remarked on the City's effort to improve and maintain excellent service delivery and commitment to affordable housing, the significant planning underway, and the change in direction that resulted from the *More Homes Built Faster Act*. She advised of the post-Covid economic climate, the impact of high inflation and interest rates on the City's finances, and noted supply chain, labour shortages and recruitment challenges. D. Joslin shared her belief that the proposed budget responded to the growing demands on the City's resources.

D. Joslin reviewed the priorities of the 2024 Draft Budget, continuous improvement results from Lean projects, and highlighted initiatives that improved external and internal customer satisfaction.

Gigi Li, Director, Financial Services and Treasurer, reviewed the progress made toward the endorsement of the 2024 Budget, purpose of Budget Committee of the Whole (BCW) meetings, and noted the presentations coming forward today and at the December 5<sup>th</sup> BCW meeting. She provided a high-level overview of the 2024 Draft Operating Budgets, the budget pressures influencing the proposed 2024 tax rate increase, the Operating Budget by department, and the tax impact on the average residential property. G. Li provided highlights on the 2024 Draft Rate-Supported Budgets, and advised of the total annual impact per residential household, the 2025 to 2027 financial outlook and concluded by outlining BCW considerations and next steps.

D. Joslin presented the Office of the City Manager 2024 Draft Operating Budget. She reviewed this year's accomplishments and 2024 priorities by division, draft budget overview by category and division, and highlighted budget changes in the Office of the City Manager.

Paolo Masaro, Executive Director, Infrastructure and Engineering Services, provided an overview of the Infrastructure Engineering Services Budget, and identified efficiencies and savings that were reflected in the Draft Operating Budget.

Regional and Local Councillor DiPaola transferred the Chair to Mayor West between 2:28 p.m. and 2:37 p.m.

Gus Galanis, Acting Commissioner of Planning and Building Services, presented the Planning and Building Services 2024 Draft Operating Budget. He reviewed this year's departmental accomplishments and priorities for 2024, and provided an overview of the draft budget by category and division. He reviewed departmental budget pressures, and identified the efficiencies, savings and revenues within the budget.

Tracey Steele, Commissioner of Community Services, presented the Community Services 2024 Draft Operating Budget. She reviewed this year's departmental accomplishments and priorities for 2024, the draft Budget by category and division, and highlighted budgetary changes to maintain the 2023 service levels in 2024. She concluded by reviewing the efficiencies, savings and revenue generating opportunities for 2024.
