#### 1. Call to Order

The Chair being absent, and the Vice-chair participating electronically in the meeting, in accordance with the City's Procedure By-law 125-23, the City Clerk called the meeting to order at 9:30 a.m., and facilitated the selection of a Chair for the January 17, 2024, Committee of the Whole meeting.

Councillor Shiu invited the community to attend a Yonge North Subway Extension Open House hosted by Metrolinx at the Langstaff Community Centre on January 25<sup>th</sup>, from 6 p.m. to 8 p.m., to learn more about the project.

Councillor Cui advised that he was hosting a Neighbourhood Watch Program public meeting on January 22<sup>nd</sup> at the Richmond Hill Central Library where York Regional Police will be in attendance to make a presentation, and invited residents of Ward 4, as well as the broader community to attend to learn about the program.

Mayor West advised that he was invited to celebrate Orthodox Christmas at the Armenian Community Centre in Toronto, joined by Councillor Thompson and Councillor Cui, and thanked the Armenian community for hosting the event.

#### 10. Delegation(s)

#### 10.1 Glen Walker, 178 Garden Avenue, regarding Property Standards Bylaw Key Findings and Directions - (refer to Item 11.2)

Glen Walker, 178 Garden Avenue, addressed Council to request that the Nuisance Lighting By-law be amended to address the excessive lighting problem at a neighboring house. He shared concerns with the constant illumination, the recent increase in wattage which heightened the annoyance, and the affect it has had on their quality of life. He provided examples of municipalities that he believed addressed the issue effectively, noting that they were all more stringent than the City's current and proposed by-law. G. Walker requested Council's assistance in implementing further restrictions within the draft by-law to rectify the problems he was facing.

### 11.1 SRCFS.24.002 - Non-Competitive Renewal of the Supply of Wireless Cellular Services

- a) That the current contract for the supply of wireless cellular services previously awarded non-competitively to Bell Mobility Inc. ("Bell Mobility") be extended for an additional term of six (6) months at a cost not exceeding \$145,000 (exclusive of taxes) pursuant to Appendix "B" Part I, Section (c) of the Procurement By-law No. 113-16 as amended by By-law 141-20 to ensure compatibility with existing deployed technologies; and,
- b) That the Commissioner of Corporate and Financial Services be authorized to execute any necessary documentation to effect the contract.

  - iii. Amendments to the Administrative Penalty By-law No. 69-16 to incorporate designated Property Standards By-law and Clean Neighbourhoods By-law offences.
