#### 1. Call to Order

The Mayor called the meeting to order at 9:31 a.m.

#### 2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

#### 3. National Anthem

The National Anthem was played.

#### 4. Public Forum (not exceeding fifteen minutes)

The following member of the public addressed Council during the Public Forum:

Michael Bowcott, 435 Easy Street, President of the Richmond Hill Pickleball Club, inquired about the status of the proposed courts to be installed at the David Dunlap Observatory Park, advised that the courts at the Richmond Green Park and Rouge Woods Community Centre were well used and enjoyed by many residents, and requested consideration of additional indoor and outdoor courts throughout the municipality. M. Bowcott extended an invitation to Council and staff to an introduction to pickleball event being held on February 4th.

#### 5. Council Announcements

Regional and Local Councillor Chan advised that he was hosting his annual New Year's Levee this Sunday, January 28th from 2 p.m. to 4 p.m. at the Elgin Barrow Arena, highlighted the many planned activities scheduled for the day, and extended an invitation for everyone to attend.

Regional and Local Chan acknowledged that today was the two year anniversary of the Mayoral by-election that was held in the City of Richmond Hill and extended continued best wishes to Mayor West.

Councillor Davidson advised that on Sunday, January 28th from 2 p.m. to 4 p.m. there would be a drop-in at the Oak Ridges Community Centre for residents to meet other members of their community and to learn more about the Neighourhood Watch Program, noting that a York Region Police Constable would be in attendance for the event.

Councillor Cui shared that this past Monday he hosted a Neighborhood Watch public meeting at the Central Library with a York Region Police Officer in attendance where they reviewed the status of the program from 2023, discussed additional streets that would qualify for the program in the upcoming year, and advised that additional Neighbourhood Watch signs were going to be installed on various streets.

Mayor West acknowledged that January was Tamil Heritage Month and highlighted the many wonderful celebrations that were taking place.

Mayor West advised that the 55th Annual Richmond Hill Winter Carnival was being held February 3rd and February 4th at the Mill Pond Park and encouraged everyone to attend to celebrate winter and participate in the various events taking place.

Mayor West reminded everyone to come out and attend one of the Traffic Safety Public Education Sessions that had been scheduled throughout the month of February at various locations across the City.

Mayor West advised that he was the Captain of the York Region Mayors Team for the annual 360°Experience taking place this year on February 29th, invited Members of Council to join, and encouraged the public to support the Team and the great work being done by 360°kids.

Mayor West noted that today was Bell Let's Talk Day which began in 2010 and discussed the importance of increasing awareness and acceptance related to mental health issues and removing the associated stigma.
