
Background:

York Region identified the need for a new Air Management Facility with odour technology for the Oak Ridge's Community in the City of Richmond Hill ("Facility"). The Facility will remove odour causing compounds from the York Durham Sewage System which has been identified as a source of odour in the area.

The new Oak Ridge's Air Management Facility will be constructed at 57 King Road, in the City of Richmond Hill near the intersection of Yonge Street and King Road. In order to service the new Facility York Region has requested permanent easements on City owned lands located at 39 King Street. The purpose of the easements are for Hydro and Gas service connections to the new York Region facility at 57 King Street.

Easements

In order to facilitate gas services, Enbridge Gas Inc. requires an easement to be registered over Part 1 on Plan 65R-39595. The easement area is 278 square metres and shown below for perspective purposes.




In order to provide hydro service Alectra Utilities requires an easement to be registered over Parts 1, 2 and 3 on Plan 65R-40694. The easement area is 263.03 square metres and shown below for perspective purposes.

City Staff has been in communications with Regional Staff and their consultants along with Alectra and Enbridge to negotiate the easement. The transfer of the easements will be at nominal consideration.
