6. Scheduled Business

6.1 Housing News and Update on City Initiatives Related to Affordable Housing - Presentation by Chun Chu, Senior Planner

Chun Chu, Senior Planner, updated the Committee on recent housing news and City initiatives related to affordable housing. She began by sharing data on affordable rental costs by unit type with comparisons made to average annual income based on minimum wage. C. Chu reviewed the proposed Federal Enhanced GST Rental Rebate, implications of Bill 134, *Affordable Homes and Good Jobs Act, 2023,* and provided an overview of Region of York Housing Updates.

C. Chu provided an update on Richmond Hill initiatives, including the Housing Accelerator Fund application, the pilot project on City-owned lands for affordable housing, and affordable housing education session.

Committee members thanked staff for the presentation and inquired whether tiny homes were considered during their analysis of potential affordable housing sites, if there was a possibility to build tiny homes on undeveloped lands; and whether there were thoughts about developing a Request for Proposal process for not-for-profit homes. Committee shared comments with respect to affordable rents transitioning to market level rents after 20 years, and suggested that the City provide support to non-profit organizations who are in the business of providing affordable housing for a longer term, and to work collaboratively with partners on the housing crisis to reduce prices.

Committee members requested clarification on the purpose of having an affordable housing education session, and suggested to diversify the panel outside of non-profit housing providers by inviting bankers, brokers and realtors, representatives from Canada Mortgage and Housing Corporation, Genworth, and Housing York. Comments were expressed regarding funding services that provided support to residents and tenants with a disability so they could remain in the community, advised of the homelessness population in Richmond Hill, and hoped the City could advocate to York Region and to Richmond Hill MPPs to increase services to individuals with mental illness.

Clarification was requested regarding the minimum wage and affordable housing rents, which economic class affordable housing was aimed for, and noted affordable housing should also be considered for the neediest in the society. Committee members shared positive remarks with respect to the proposed changes to the definition of affordable housing regarding Bill 134 Affordable Homes and Good Jobs Act, 2023; the proposed Federal Enhanced GST Rental Rebate; Housing Accelerator Fund from the Federal government; York Region Housing update; the pilot project for

City-owned lands for affordable housing; and shared their desire to incorporate building affordable units above future single-storey City developments, such as Fire Halls.
