

# The Corporation of the City of Richmond Hill

## By-Law 35-24

A By-law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being By-law 402-89, as amended, relating to parking regulation

Whereas on November 6<sup>th</sup>, 1989, the Corporation of the City of Richmond Hill (the “City” enacted by By-law 402-89 that regulates the parking of motor vehicles on public highways and other property (“Parking Regulation By-law”).

**Now Therefore The Council Of The Corporation Of The City Of Richmond Hill Enacts As Follows:**

- 1. That Schedule ‘A’ – Parking Prohibited – Signs – Displayed in Chapter 1116, being By-law 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by deleting the following rows:
