#### 1. Call to Order

As the Mayor was participating electronically in the meeting, in accordance with the City's Procedure By-law 125-23, the Deputy Mayor assumed the Chair.

The Deputy Mayor called the meeting to order at 9:30 a.m.

#### 2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

#### 3. National Anthem

The National Anthem was played.

#### 4. Public Forum (not exceeding fifteen minutes)

Aram Rajabpour, 49 Carrington Drive, addressed Council regarding safety concerns for pedestrians using the Major Mackenzie Bridge, noting the many students who use the Bridge from the nearby high school and the proposed development to the east which would increase pedestrian traffic, and requested that bollards be installed on each side of the road as a proactive safety measure.

#### 5. Council Announcements

Councillor Cilevitz thanked the resident who addressed Council during the Public Forum advising of her support for the concerns that were identified, and noted that Major Mackenzie Drive was a Regional road and the Regional representatives on Council would be able to able to discuss this matter with him.

Councillor Cilevitz advised that May 5th to 11th was the 55th Annual Professional Municipal Clerks Week. She acknowledged Richmond Hill's City Clerk, Deputy City Clerk and Clerk's staff, and on behalf of Council and residents, extended thanks for all the work that they do for the municipality.

Councillor Cilevitz noted that this past Monday Yom HaShoah was observed and shared the significance of the Holocaust Remembrance Day and the vow "Never Again" in light of the terrorist attacks against Israel and the rise in antisemitism.

Councillor Cui advised that this Sunday was Mother's Day and wished everyone a Happy Mother's Day. He further noted that he was hosting a Mother's Day Lunch at the McConaghy Centre on Friday that residents were welcome to join.

Councillor Cui shared that the Ward 4 food drive that was held this past weekend was very successful and extended his thanks for the generous donations and efforts of residents to help those in need.

Councillor Cui advised that Saturday, May 11th was the annual Strides for Mackenzie Health community run/walk event being held at Canada's Wonderland and encouraged everyone to join.

Councillor Cui noted that the Richmond Hill Sports Awards ceremony was held last week and thanked City staff for organizing and supporting the event and extended congratulations to all the award recipients.

Councillor Davidson echoed the comments made by Councillor Cilevitz regarding the Annual Professional Municipal Clerks Week and thanked the City Clerk, Deputy City Clerk and Clerk's staff for their help, and acknowledged the support that was given to new Members of Council since the beginning of the term.

Councillor Davidson advised that Saturday, May 11th was the annual Oak Ridges Lions Club Community Clean Up at the Academie de la Moraine Elementary School, and encouraged anyone that has time to come out and help.

Regional and Local Councillor DiPaola shared that in collaboration with York Regional Police, he was hosting a Senior Safety Seminar on Friday, May 10th at the Rouge Woods Community Centre and welcomed everyone to attend.

Regional and Local Councillor DiPaola congratulated Richmond Hill resident Taylor Pendrith on his first PGA Tour title after winning The CJ Cup Byron Nelson tournament this past weekend, and highlighted the success of the many athletes from Richmond Hill at the national and international level as seen last week at the Richmond Hill Sports Awards ceremony.

Mayor West also extended congratulations to Richmond Hill golfer Taylor Pendrith on winning his first PGA Tour title.

Mayor West highlighted a number of significant dates in the month of May including: World Migratory Bird Day (May 11, 2024), National Hospice Palliative Care Week (May 5 to 11, 2024), Melanoma Skin Cancer Awareness Month (May 2024), Canadian Mental Health Week (May 6 to 12, 2024) with a theme of "A Call to be Kind", and National Youth Week (May 1 to 7, 2024).

Councillor Thompson advised of a number of events happening on Saturday, May 11th including the Richmond Hill Garden and Horticultural Society's annual plant sale at the McConaghy Centre, 2024 Studio Tour in partnership with Doors Open Richmond Hill, and the L'Arche Daybreak's Walk with Hope event.

Deputy Mayor Chan also noted that May 6th to 12th was Canadian Mental Health Week and highlighted the many programs in the York-Simcoe area that were offered to assist youth, families and caregivers.

Deputy Mayor Chan recognized the courageous men and women who work for Richmond Hill's Fire and Emergency Services as May 5th to 11th was Emergency Preparedness Week with a theme of "Plan for Every Season" and noted that the educational brochures were being published in multiple languages.

Deputy Mayor Chan announced that today was the annual McHappy Day and shared that he and many of his Council colleagues would be volunteering to serve residents at different McDonald's restaurants within Richmond Hill in support of the Ronald McDonald House Charities.

Maria Asper, 600 Alden Road, Markham, and resident of May Avenue, spoke on behalf of herself and multiple residents of May Avenue regarding the proposed Official Plan Amendment, Zoning By-law Amendment and Draft Plan of Subdivision Applications submitted by Elm 9700 Yonge LP for 9700 Yonge Street. She advised of several concerns that they had with the proposed development because of the height and density, impact on area traffic flow and congestion, parking and street safety, and inquired about public transit usage and the validity of the traffic studies. She

further expressed their concerns regarding light pollution; the impact on the environment, schools, social and emergency services; and devaluation of their properties as a result of rental units. M. Asper requested copies of the traffic and parking studies that were conducted, and full disclosure on urban planning for Yonge Street.
