

## The Corporation of the City of Richmond Hill

### By-Law 55-24

A By-law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being by-law 402-89, as amended, relating to parking regulation.

**WHEREAS** on November 6<sup>th</sup>, 1989, the Corporation of the City of Richmond Hill (the “City” enacted by by-law No. 402-89 that regulates the parking of motor vehicles on public highways and other property (“Parking Regulation By-law”).

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF RICHMOND HILL ENACTS AS FOLLOWS:**

1. That Schedule ‘A’ – Parking Prohibited – Permit Required, in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by deleting the following rows in alphabetical order:
