Purpose:

The purpose of this report is to advise Council of the resignation of Heritage Richmond Hill's (HRH) Education Community representative, and to recommend that for the remainder of the current Term of Council, the Heritage Richmond Hill Committee be authorized to operate without an Education Community representative.

- c) That, for the remainder of the 2022 to 2026 Term of Council, the Heritage Richmond Hill Committee be authorized to operate without an Education Community representative and without making any amendments to the Committee's composition as outlined in its Terms of Reference.

Key Messages:

- Since the beginning of this Term of Council, HRH has had two Education Community representatives resign;
- City staff have faced challenges in receiving timely nominations from the four School Boards in Richmond Hill regarding their recommendation of an individual for consideration as the Education Community representative;
- Staff are seeking Council approval for Heritage Richmond Hill to operate without an Education Community representative for the remainder of the 2022 to 2026 Term of Council.

Background:

On January 24, 2024, Richmond Hill City Council appointed Trustee Crystal Yu to the Heritage Richmond Hill Committee as its Education Community representative due to the resignation of the Education Community representative appointed at the beginning of this Term of Council, Tom Pechkovsky, who resigned on November 14, 2023.

On March 27, 2024, the Office of the Clerk was notified by the Manager of Trustee Services with the York Region District School Board that Trustee Crystal Yu had resigned as both a Trustee and as the Education Community representative for the Heritage Richmond Hill Committee. Subsequent to this, the Office of the Clerk conducted a By-election for the York Region District School Board Trustee, Wards 1, 2, and 4.

Discussion:

Since the beginning of this Term of Council, two Education Community representatives, Tom Pechkovsky and Crystal Yu, have resigned from the Heritage Richmond Hill Committee. Appointments to the Heritage Richmond Hill Committee are decided by Council and require City staff to reach out to the four School Boards in Richmond Hill to receive their recommendation for nominations to HRH for Council's consideration.

Previous recruitment requests to the four School Boards have yielded minimal nominations, making the appointment of an Education Community representative to the Heritage Richmond Hill Committee a challenge due to lack of nominations.

Given the difficulty of retaining and receiving nominations for an Education Community representative, Staff recommend that the Heritage Richmond Hill Committee be authorized to operate without an Education Community representative for the remainder of this Term of Council and without making any amendments to the Committee's composition as outlined in its Terms of Reference (Attachment A for reference).
