Background:

Section 4.8(a) of the Procedure By-law No. 125-23 ("Procedure By-law"), requires the City Clerk to prepare an annual Council and Committee meeting schedule for Council's consideration.

Discussion:

Attached to this report as Appendix "A" is the proposed 2025 Council and Committee meeting schedule for Council's approval. The proposed schedule includes all the regular Council, Committee of the Whole and Council Public Meetings required by the Procedure By-law. The proposed schedule also includes up to three (3) Tuesday meeting holds each month which can be used to schedule any Special Council Meeting or other Committee meetings (e.g. Budget Committee of the Whole).

In preparing the proposed 2025 meeting schedule, the City Clerk considered religious festivals/holidays, statutory and civic holidays, March Break as determined by the York Region School Boards, both summer and winter recess periods and other scheduled events such as the Federation of Canadian Municipalities (FCM) and Association of Municipalities of Ontario (AMO) annual conferences. Where scheduling conflicts may arise for any reason (such as due to a holiday or scheduled City event), the City Clerk adjusts and recommends alternative days within the proposed schedule.

Committees of Council and External Boards

The proposed meeting schedule will be updated once dates for other Committees of Council and external boards have been confirmed. For further clarity, Committees of Council generally utilize the meeting holds set forth in the proposed schedule.
