#### 1. Call to Order

The Chair called the meeting to order at 9:30 a.m.

### 2. Council Announcements

With Rosh Hashanah approaching, Mayor West extended a Shana Tovah greeting to all the Jewish residents of Richmond Hill.

Mayor West acknowledged the numerous events held in Richmond Hill in recognition of the National Day for Truth and Reconciliation, and thanked those who attended the flag raising last Wednesday.

Mayor West shared that he attended an event with Councillor Davidson at Lake Wilcox Park in recognition of the National Day for Truth and Reconciliation. He acknowledged the difficult truths that must be faced before reconciliation can occur, and emphasized the importance of considering how we can be allies to Indigenous peoples every day.

Councillor Davidson acknowledged the National Day for Truth and Reconciliation event that took place at Oak Ridges Community Centre, and remarked on the meaningful and enlightening conversation, and encouraged everyone to attend next year.

Councillor Davidson announced that she is hosting an event on Sunday from 1 p.m. to 3 p.m., which will include a concert and an opportunity to drop off e-waste. She encouraged attendees to ride their bikes, as a bike valet will be available, and expressed her hope to see everyone there this weekend.

Councillor Cui acknowledged the success of the Mackenzie Health fundraising event that took place last week and expressed gratitude to everyone for their generosity.

Councillor Thompson announced that he will be hosting ECO-Family Fest at Town Park on Saturday, October 5th. He invited everyone to attend, highlighting that it is a free event featuring a complimentary barbeque and an opportunity to explore innovative products that promote a more sustainable future.

### 10. Delegation(s)

10.1 Vincent Ching, 9017 Leslie Street, on behalf of York Region Standard Condominium Corporation #972 and #1008, regarding Completion of Comprehensive Official Plan Update and Secondary Plan Approach -(refer to Item 11.2)

Vincent Ching, board member on the York Region Standard Condominium Corporation #972 and #1008, addressed Committee regarding Completion of Comprehensive Official Plan Update and Secondary Plan Approach. He advised of their support of the recommendations within the associated staff report to complete the Official Plan (OP) update in the East Beaver Creek and Highway 7 area, noting that it was necessary before the City can consider development proposals that do not meet the current OP guidelines. He further conveyed their desire as a stakeholder to be involved in the consultation and public engagement process when the OP update and Secondary Plan for the area is developed. V. Ching advised that they had raised objections to the development application submitted by Parkway Hotels, noting that the proposal did not meet the current OP policies, citing concerns with height, density, transportation infrastructure, and traffic congestion on Highway 7.

10.2 Lauren Capilongo, Malone Given Parsons Ltd., on behalf of Parkway Hotels and Convention Centre Inc., 650 Hwy 7 East Inc., and 9005 Leslie Street Inc., regarding Completion of Comprehensive Plan Update and Secondary Approach - (refer to Item 11.2)

Lauren Capilongo, Malone Given Parsons Ltd., on behalf of Parkway Hotels and Convention Centre Inc., addressed Committee regarding Completion of Comprehensive Plan Update and Secondary Approach and requested that the Sheraton Parkway lands be excluded from the Secondary Plan process, arguing that their Official Plan amendment,

submitted in March 2023, should be handled as a tertiary or concept planning exercise. She expressed concerns that the Secondary Plan process, set to begin in 2026, was a long way off, arguing that the OP amendment application submitted by Sheraton could effectively address the same elements as a Secondary Plan but on a smaller and more focused area. She noted that it had already been four years since the Sheraton lands were converted from employment use, with little progress made on policy updates. She shared her opinion that keeping the Sheraton lands within the Secondary Plan process would hinder the development of a major hotel and convention center and much-needed housing and emphasized Sheraton's long-standing presence and commitment to the community.

### 11. Committee and Staff Reports

### 11.1 SRCM.24.09 - Community Sport and Recreation Infrastructure Fund – Grant Applications

- a) That Council endorse the City's submission of applications to the Community Sport and Recreation Infrastructure Fund (CSRIF) for the following:
  - i) Stream 1 application for Repair and Rehabilitation Projects Lake Wilcox Park Playground and Splash Pad Resurfacing Project; and
  - ii) Stream 2 application for New Builds Brickworks Park Revitalization Project;
- b) That should one or both of the City's Community Sport and Recreation Infrastructure Fund grant applications be successful, Council approve:
  - i) That the Lake Wilcox Park Playground and Splash Pad Resurfacing Project proceed with a \$395,700 budget, with approximately \$197,850 to be funded from the Provincial CSRIF, and the remaining City portion to be funded from appropriate funding sources, as determined by the Treasurer;
  - ii) That the Brickworks Park Revitalization Project proceed with a \$2,000,000 budget, with approximately \$1,000,000 to be funded from the Provincial CSRIF, and the remaining City portion to be funded from appropriate funding sources, as determined by the Treasurer.

- c) That staff be directed to explore additional growth and intensification in the Regional Mixed-Use Corridor designation through increases to maximum densities and building heights;
- d) That staff be directed to commence the preparation of a comprehensive Secondary Plan for the area of East Beaver Creek Road and Highway 7 in 2026, subject to budget approval through the 2026 Capital Budget process;
- e) That staff be directed to commence the preparation of a comprehensive Secondary Plan for the area of Bathurst Street and Highway 7 in 2027, subject to budget approval through the 2027 Capital Budget process; and,
- f) That the Mayor and City Clerk be authorized to execute any necessary documentation to give effect to consulting services contracts recommended in SRPBS.24.078, upon the recommendation of the Commissioner of Planning and Building Services.

c) That the Commissioner of Corporate and Financial Services, and upon the recommendations of the Chief Information Officer, be authorized to execute any necessary documentation to effect the contract(s).

That the appropriate City of Richmond Hill staff report back to the October 16th Committee of the Whole with a strategy on how Richmond Hill can enter into an agreement with Jolt to install electric vehicle charging billboards on city property at multiple locations.
