1. Call to Order

The Mayor called the meeting to order at 9:30 a.m.

Mayor West transferred the Chair to Regional and Local Councillor Chan between:

- 10:21 a.m. and 10:50 a.m. during consideration of Item 15.3.

Council consented to recess the meeting between 11:23 a.m. and 11:34 a.m. during Closed Session.

2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

3. National Anthem

The National Anthem was played.

4. Public Forum (not exceeding fifteen minutes)

4.1 Daniel Segal, 46 West Lynn Avenue, Toronto, regarding Municipal Housing Development

Daniel Segal, 46 West Lynn Avenue, Toronto, addressed Council regarding a proposal for municipal residential development of attainable housing. He advised that he has been advocating to all municipalities in the province to have them consider building compact communities to meet the need of affordable housing, and requested that either the City of Richmond Hill or the Region of York add a line item in their capital budget for this project.

5. Council Announcements

Councillor Cilevitz shared that October 7th was the annual remembrance day of when Israel was invaded last year which has now become a very important day to the Jewish community, and extended thoughts and prayers to the Israeli people and everyone impacted.

Councillor Cilevitz advised that this week was one of the most holy weeks in the Jewish religion as celebrations take place for Rosh Hashana and Yom Kippur and wished all Jewish neighbours, friends and family a Shana Tova and shared her wish that we all see peace again soon.

Councillor Thompson advised of the success of his ECO Family Fest event held last Saturday at the Elgin Barrow Arena and Town Park noting that close to 1000 residents attended, acknowledged the staff in Event Services and Public Works for their help in organizing the event, and shared that next year's ECO Family Fest has already been scheduled for September 20, 2025.

Councillor Cui advised that this evening in Ward 4 there was a Traffic Safety and Operations Strategy Public Education Session being held at the Elgin West Community Centre with City staff to be in attendance, noted the 3 upcoming traffic calming projects, and extended an invitation to anyone interested to attend.

Regional and Local Councillor DiPaola extended congratulations to Councillor Thompson and Councillor Davidson on the success of their ECO Family Fest and Oak Ridges Green Beats Day events.

Regional and Local Councillor DiPaola acknowledged the success of the Mayor's Annual State of the City Address yesterday at the Richmond Hill Board of Trade luncheon at the Sheraton Parkway Hotel and congratulated the Mayor on his speech that highlighted the many great things happening in Richmond Hill as we build a great city of neighbours.

Councillor Davidson shared that a lot of fun was had this past Sunday at her Oak Ridges Green Beats Day event that included a great band and free ice cream, and for those that weren't able to attend there is another opportunity to come out next week.

Regional and Local Councillor Chan echoed the comments made regarding the success of the events held by Councillor Davidson and Councillor Thompson that shared a common theme of looking after our world, and the inspiring speech given by the Mayor yesterday at the Annual State of the City Address at the Richmond Hill Board of Trade luncheon.

Regional and Local Councillor Chan advised that he hosted his first Coffee Sunday on Budgets this past weekend and extended his thanks to City staff for attending to help provide information to residents, and to everyone who attended to provide their input.

Mayor West shared that two new high level hockey teams have been added to the community, the Richmond Hill Rampage of the Greater Metro Junior A Hockey League where he attended their first game this past Friday to drop the puck, and the Richmond Hill Coyotes of the Ontario Super Hockey League who held their inaugural game this past Sunday.

Mayor West acknowledged the impact of Hurricane Milton on the state of Florida and extended thoughts and prayers to everyone affected, including those in the City of Richmond Hill's sister city Lakeland, Florida.

13. Presentation(s)

13.1 Presentation by Gigi Li, Director, Financial Services and Treasurer, to Mayor West and Members of Council of the Government Finance Officers Association (GFOA) Distinguished Budget Presentation Award for the City of Richmond Hill's 2024 Budget

Gigi Li, Director, Financial Services and Treasurer, on behalf of the Financial Services Division, made a presentation to Mayor West and Members of Council of the Government Finance Officers Association

(GFOA) Distinguished Budget Presentation Award which was awarded to the City of Richmond Hill for its sound approach to public finances with the GFOA for its 2024 Budget Book. She provided background information on the Award and advised that the City was recognized as an example of excellence in government budget best practices throughout North America and had to meet nationally recognized guidelines, and that receiving the Award was a testament to Richmond Hill's long-standing commitment to transparency and effective management of resources. G. Li acknowledged and extended her congratulations to the staff in the Financial Services and Communication Services Divisions for their dedication and collaboration and presented the GFOA Distinguished Budget Presentation Award to Mayor West and Members of Council.

14. Delegation(s)

14.1 Whinney Wong, 9017 Leslie Street, regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach - (refer to Item 15.3)

Whinney Wong, 9017 Leslie Street, addressed Council regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach. She expressed her concerns with the lack of parks, community centres and libraries that are accessible to the residents in the area and that she was hopeful the new Secondary Plan would address this to make their neighbourhood a better place to live. W. Wong requested that Council not compromise the integrity of the Secondary Plan process and take into consideration residents' concerns.

14.2 Dennis Ngai, 9017 Leslie Street, Unit 806, regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach - (refer to Item 15.3)

Dennis Ngai, 9017 Leslie Street, Unit 806, addressed Council regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach. He advised that he objected to the Sheraton Parkway lands being exempt from the Comprehensive Official Plan Update and the Secondary Plan for the area of East Beaver Creek Road and Highway 7, referencing the information in the staff report relating to the Official Plan amendment application that had been submitted for the lands and the benefit of having an updated policy framework in place to guide these types of proposals. D. Ngai highlighted the importance of undergoing the Secondary Plan process as it would identify transportation and infrastructure impacts for the area and determine whether it was

sustainable, and requested that Council not ignore the recommendations of staff contained in the report.

14.3 Bill Chong, 9015 Leslie Street, regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach -(refer to Item 15.3)

Bill Chong, 9015 Leslie Street, addressed Council regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach. He discussed the Official Plan amendment that had been submitted by the Sheraton Parkway in the context of the Official Plan Update and Secondary Plan process, and shared that in his opinion, the proposed height and density of the proposal on the subject lands was too aggressive and would not benefit the community. B. Chong advised that the Sheraton Parkway lands should not be exempt from the Comprehensive Official Plan Update and the Secondary Plan for the area of East Beaver Creek Road and Highway 7 and urged Council to uphold their mission statement that they made to the community.

14.4 Lawrence Lee, YRSCC 972, 9015 Leslie Street, regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach - (refer to Item 15.3)

Lawrence Lee, YRSCC 972, 9015 Leslie Street, addressed Council regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach. He highlighted the number of residents who were in attendance at the meeting to observe how Members of Council would vote on this matter and expressed his hope that any decision made would represent the residents that elected them. L. Lee requested that Council approve the staff recommendations to complete the Comprehensive Official Plan Update and Secondary Plans to guide future development and pause consideration of any development applications for the area until the process has been completed.

14.5 Cliff Chu, 9015 Leslie Street, regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach - (refer to Item 15.3)

Cliff Chu, 9015 Leslie Street, addressed Council regarding the Completion of Comprehensive Official Plan Update and Secondary Plan Approach. He complemented the report that staff put together on this matter and expressed his concerns with the Official Plan amendment application that had been submitted by the Sheraton Parkway in the context of its location,

policy planning framework, and their possible exemption from the Comprehensive Official Plan Update and the Secondary Plan process. C. Chu urged Members of Council to make a decision that was favourable to the local residents and to the entire community.

14.6 Vincent Ching, YRSCC 972 and 1088, 9017 Leslie Street, regarding Completion of Comprehensive Official Plan Update and Secondary Plan - (refer to Item 15.3)

Vincent Ching, YRSCC 972 and 1088, 9017 Leslie Street, addressed Council regarding Completion of Comprehensive Official Plan Update and Secondary Plan. He expressed his concerns with the possibility of the Sheraton Parkway lands being exempt from the Comprehensive Official Plan Update and the Secondary Plan for the area of East Beaver Creek Road and Highway 7, the rationale that was given for considering the exemption, and the precedent it would set if permitted. V. Ching noted that the Official Plan amendment application that had been submitted by the Sheraton Parkway was not in compliance with current policies and would negatively impact the quality of life for area residents, and requested that Council approve the staff report recommendations and not consider any exemptions, as detailed in his correspondence distributed as Items 15.4 and 15.6.
