1. Call to Order

5. Delegation(s)

Delegation by Alexander Chang, 14 Vitanna Road, Markham, regarding the Notice of Intention to Designate 11644 Leslie Street – (refer to Item 6.2)

Alexander Chang, 14 Vitanna Road, Markham, representing his parents, owners of the property, addressed Committee regarding the Notice of Intention to Designate 11644 Leslie Street. He advised that his parents purchased the property in the late 1980s, and lived there until mid-2000s, after which they began renting it out. He advised that they were opposed to the designation of the home, and noted that the home was in poor condition, and the rental was not financially practical due to high utility costs and inefficiencies in heating the home. A. Chang expressed their intention to either demolish the home or donate it to the City for relocation to a suitable site, and indicated they would like to come to a compromise on this matter.

Delegation by Joyce Horner, 32 Love Court regarding the Notice of Intention to Designate 11644 Leslie Street - (refer to Item 6.2)

Joyce Horner, 32 Love Court, addressed Committee regarding the Notice of Intention to Designate 11644 Leslie Street. She reviewed her family's settlement to Richmond Hill, advised that the property originally comprised of 200 acres on Major Mackenzie Drive East between Bayview Avenue and Leslie Street, noted the lands were subdivided over time, and that this property was the last remaining parcel. She emphasized the importance of the Horner House noting it historically served as a community hospital. She stated that in her opinion, the current owners may have neglected the home, contributing to its poor condition as mentioned by the previous delegate, and expressed her desire to see the home preserved and designated for protection.

Delegation by Tiziano Fantin, 16 Macleod Estate Court regarding the Heritage Permit for 16 Macleod Estate Court Tree Removal - (refer to Item 6.7)

Tiziano Fantin, 16 Macleod Estate Court, addressed Committee regarding the Heritage Permit for 16 Macleod Estate Court Tree Removal. He advised that he submitted a Heritage Permit Application to formally recognize the removal of the fallen Silver Maple tree on the property and expressed his intention to have an Indigenous artist create a sculpture utilizing the tree trunk to commemorate the area's rich Indigenous heritage. He explained that his arborist assessed the tree stump and found it to be decayed and unsuitable for carving. He shared his desire to work with the Committee and City staff to replace the tree, and suggested that if the City had inventory wood from another site that was indigenous to the property, it could be considered for the carving project to honour Indigenous heritage. T. Fantin highlighted their commitment to maintaining the property's integrity, the importance of preserving the Mcleod Estate, and noted that all associated costs would be borne by his family.

6.2 SRPBS.24.081 - Notice of Intention to Designate 11644 Leslie Street - City File D12-07275

Committee members raised concerns regarding the implications of designating a property that the owner could not afford to maintain. They commented on the owner's situation and requested clarification on maintenance obligations post-designation. Staff clarified that the designation would not alter existing Property Standards requirements, which had to be met regardless of designation status and explained that the designation would not prevent property sales or renovations, and that the Property Standards By-law applied to all properties.

Several members expressed their support for the designation, emphasizing the historical significance of the property and concerns about potential demolition. The Committee acknowledged that the designation process allowed the owners to address issues before a final decision was made.

6.7 SRPBS.24.091 - Heritage Permit for 16 Macleod Estate Court Tree Removal - City File No. D12-07230

Committee Members acknowledged the owner's commitment to maintaining the property's integrity and concerns were raised about the practicality of working with the decayed stump, given that it would not support a carving. Committee members expressed their support to secure an Indigenous artist to collaborate with staff and the homeowner on a design that would commemorate the area's Indigenous heritage, while remaining flexible to options other than carving the stump.

b) That Council direct Heritage Planning staff to work with the owners of 16 Macleod Estate Court to secure an Indigenous artist who will work with staff and the homeowner to install a design that commemorates the area's Indigenous heritage within the location of the stump of the fallen Silver Maple tree described in staff report SRPBS.24.091;

c) That the heritage permit application to formally recognize the removal of the fallen Silver Maple tree at 16 Macleod Estate Court, as described in staff report SRPBS.24.091, be approved.

6.8 Heritage Designation Strategy and Heritage Planning to date in 2024 - Verbal Update by Kunal Chaudhry, Manager, Heritage and Urban Design

Kunal Chaudhry, Manager, Heritage and Urban Design provided a verbal update regarding the Heritage Designation Strategy and Heritage Planning to date in 2024. He advised that the Committee had processed eight Heritage Permit Applications, which included repairs and maintenance for the David Dunlap Observatory, and noted staff's ongoing efforts to ensure the timely completion of the projects. He reviewed the implementation of the Designation Strategy in response to Bill 23 and highlighted their proactive approach to property designations. He advised that staff recommended designating 22 properties, 19 of which had already received support by the Committee and Council, and the third batch would be considered by the Committee of the Whole on October 16, 2024, followed by Council on October 23, 2024. K. Chaudhry advised that one formal Notice of Objection was received, and reviewed the extension granted by Bill 200, which set the new deadline for Bill 23 designations to December 31, 2026, for the continued protection of heritage properties.

Committee members expressed their gratitude to staff for their hard work and sought clarification on the property that had been appealed and inquired about the strategy for designating properties in the coming year.
