### Subject: SRCFS.24.060 - 2025 Budget - Village of Richmond Hill Business Improvement Area

#### Purpose:

To provide Council with the 2025 Budget from the Village of Richmond Hill Richmond of Hill and levy funding requirements.

#### **Recommendations:**

- a) That staff report SRCFS.24.060 regarding the 2025 Budget for the Village of Richmond Hill Business Improvement Area be received;
- b) That the Budget Committee of the Whole recommends that the Mayor submit for Council's review:
  - i. That the 2025 gross operating budget of \$182,540 for the Village of Richmond Hill Business Improvement Area as provided in staff report SRCFS.24.060 be approved;
  - ii. That \$120,000 be levied upon the rateable properties in the improvement area.

## **Report Approval:**

All reports are electronically reviewed and/or approved by the Division Director, Treasurer (as required), City Solicitor (as required), Commissioner, and City Manager. Details of the reports approval are attached.

## **Background:**

The responsibility of a Business Improvement Area Board, in accordance with the Municipal Act, is as follows:

(1) A board of management shall prepare a proposed budget for each fiscal year by the date and in the form required by the municipality and shall hold one or more meetings of the members of the improvement area for discussion of the proposed budget.

(2) A board of management shall submit the budget to Council by the date and in the form required by the municipality and the municipality may approve it in whole or in part but may not add expenditures to it.

The Village of Richmond Hill Business Improvement Area (BIA) Board conducted their meetings to establish a proposed budget for 2025.

# **Financial Implications:**

The Village of Richmond Hill Business Improvement Area's 2025 proposed budget is \$182,540, with 62,540 to be funded by the BIA Reserve Fund. The remaining amount of \$120,000 would be fully funded by a tax levy upon the rateable properties in the area, as part of the final tax billing.

The 2024 year-end reserve fund balance is projected to be \$127,072 after drawing the approved 2024 allocation.

The presentation of the 2025 Draft Rate Supported Operating Budgets relates to Pillar 3, Strengthening our Foundations, specifically Priority 1, Make decisions that are evidence-based and data-driven to enable the City's long term financial sustainability, as well as social, environmental and economic sustainability.
