1. Call to Order

4.1 Minutes - Accessibility Advisory Committee meeting AAC#01-24 held February 22, 2024

6. Scheduled Business

6.1 Building Code - Accessibility - Presentation by Nadim Khan, Director, Building Division and Chief Building Official

Nadim Khan, Director, Building Division and Chief Building Official, provided an overview of the National Building Code, emphasizing its role as a legislative framework that informed provincial building codes. He discussed the scope of the Building Code Act (Act), its objectives, the responsibilities of municipalities under the Act, and the incorporation of accessibility principles within the legislation. N. Khan highlighted examples of specific accessibility requirements and addressed a few of the regulatory challenges within the Act. He also noted that a revised Building Code will take effect on January 1, 2025.

Committee members sought clarification on the scope of the Act, particularly regarding which types of buildings it applied to and whether it extended to elements outside of buildings. Concerns were raised about the Act's limitations in mandating accessibility requirements for smaller residential buildings, as well as the minimal number of units that are required to be accessible in larger buildings. Committee members inquired about how residents can advocate for changes to accessibility standards across various levels of government. Additionally, there were questions regarding the lack of public input in the City's building permit application process.

6.2 Overview of the Programs and Support offered by York South Family Network to Lifetime Caregivers in Richmond Hill - Presentation by Monica Missaghi, Co-founder, York South Family Network, and Committee Member Sherry Caldwell

Committee member Sherry Caldwell and Monica Missaghi, co-founders of the York South Family Network (YSFN), made introductory remarks, and shared their personal experiences as caregivers for family members with special needs. They explained the role of a lifetime caregiver and emphasized how both caregivers and children with disabilities have been excluded from government funded programs. They further remarked on the financial, physical and emotional toll that caregiving has on caregivers.

M. Missaghi shared the history and purpose of the YSFN, explaining how it brings caregivers together through planned events that are either free or offered at minimal cost. She highlighted the benefits these gatherings provide to caregivers, emphasized the growing need in the community, as evidenced by the rising registration numbers for their events, and concluded by thanking Richmond Hill for their support.

Councillor Cilevitz thanked Sherry Caldwell and Monica Missaghi for their presentation and for the valuable support they provide to caregivers through their organization.

6.3 2023 Status Report on the 2023-2027 Multi-Year Accessibility Plan - Presentation by Natasha McLarty, Legislative and Special Projects Officer

Natasha McLarty, Legislative and Special Projects Officer, provided introductory remarks regarding the Multi-Year Accessibility Plan (MYAP), and the legislative requirements to provide progress reports each year. She provided an update on Richmond Hill's ongoing efforts to deliver accessible customer service, ensure clear and accessible information, implement inclusive employment practices, and design accessible public spaces. She also highlighted the general accessibility initiatives in 2023, and outlined their goal to meet the targets specified in the 2023-2027 MYAP.

Committee members sought clarification on which parks had received accessibility improvements, and emphasized the importance of making parks accessible.

Committee member Sherry Caldwell advised of her attendance at the York Region National AccessAbility Week Professional Development Forum in May. She noted that the Accelerating Accessibility Coalition (AAC) was the keynote speaker, and shared their role in advocating to make accessibility

in housing more of a priority in Canada. S. Caldwell expressed her hope that the City of Richmond Hill will join the AAC, and encouraged all committee members to attend the forum next year, highlighting that it brought together members of accessibility advisory committees from across York Region and featured valuable speakers and relevant topics for discussion.
