Committee members expressed their disappointment with the circumstances that have led to the demolition request of the Robert Hewison House, noting its loss would significantly impact the historical character of the village. There was understanding amongst Committee members that the demolition request should go forward, as the building posed a public safety concern. Staff clarified that the other properties on the lot will remain protected by the designation by-law.

Comments were made regarding the possibility of a replica of the building being constructed, with staff clarifying that conditions could not be tied to a demolition permit due to the statutory timelines that needed to be met. In response to questions, staff identified two avenues in which a request for a replica could be brought forward to Council: either through a member motion, or through recommendations within a staff report when the amending designation by-law is brought forward.
