1. Call to Order

6. Scheduled Business

6.1 Update on City Initiatives Related to Affordable Housing

Chun Chu, Senior Planner – Policy, welcomed the new Affordable Housing Strategy Implementation Committee member Christopher Robinson, a representative from Habitat for Humanity GTA, and introduced a new staff member Ashley Dickinson, as the Affordable Housing Project Manager. She continued by reviewing the topics on today's meeting agenda concerning the City's affordable housing initiatives.

C. Chu began the presentation by reviewing the purpose of the Community Improvement Plan (CIP) for affordable housing and sustainable design. She explained that the Housing Accelerator Fund (HAF) was the major funding source for the CIP, and that the final CIP was targeted for presentation at the November 20, 2024, Committee of the Whole meeting, with implementation set to begin in early 2025. She continued by summarizing the eligibility criteria, the four incentive streams available, and project selection evaluation criteria for the CIP. C. Chu reviewed the purpose of the Housing Needs Assessment and Inclusionary Zoning Impact Assessment, highlighting the three staff reports that were being brought forward to the Committee of the Whole on November 6, 2024. She summarized key findings for housing demand, supply, and affordability, noting that persistent housing gaps since 2021, further validated the goals of the Affordable Housing Strategy.

C. Chu explained Inclusionary Zoning (IZ), highlighted updates to the Peer Review of the 2021 Inclusionary Zoning Impact Assessment and provided details about the 2024 Inclusionary Zoning Impact Assessment. She concluded the presentation by outlining staff's recommendations and the date of the next committee meeting.

Committee members inquired about the issuance of Building Permits under the HAF program, and the percentage allocated to deeply affordable housing. Staff affirmed the City's commitment to building a specific number of units by 2026, noting that while the City's planning process was more efficient, the decision to proceed with construction remained with the developers.

Members sought clarification on aspects of the CIP related to municipal land availability, specifically regarding the target of 80% of the average market rate and mixed-income projects. They also inquired whether the application process would be an open call or conducted annually, inquired about stakeholder interest and support, and requested details about risk mitigation measures for the CIP.

Staff responded to the Committee's questions by explaining how the CIP program could incentivize future use of public lands when available. They added that a Request for Proposal (RFP) process detailing project criteria and eligibility, would be implemented in early 2025. Additionally, staff noted that the CIP program would be promoted on the City's website, and through direct outreach to stakeholders. Staff noted that they were aware of several interested developers who would likely meet the criteria for the CIP and that the development of an affordable housing concierge program was being designed to expedite the application process and inform developers about additional government funding programs. The Committee expressed optimism about the CIP program, noting its significant potential to enhance housing affordability.
