Purpose:

To propose a name for a new park within the City's park and natural heritage system.

- That the proposed name "Heron View Park" be advertised on the City's website with request for public comments in accordance with the City's Policy for Naming and Renaming Parks, Open Space and Recreational Facilities; and
- c) That staff report back to Council regarding public comments on the proposed "Heron View Park" name and with a final recommendation for naming the site.


Background:

The report proposes a park name that is consistent with the City's Policy for Naming and Renaming Parks, Open Space and Recreation Facilities (see Appendix A), for a site within the City's Park and Natural Heritage system as follows:

Heron View Park (Park Class: Community Park)

Location: Ward 3, Bawden Drive, see Map 1

Discussion:

The name "Heron View Park" references the Great Blue Heron, which was recently named Richmond Hill's 'Bird Friendly City' bird. The proposed park name will provide further recognition and tribute to this City symbol and the nearby Heron rookery. Birds play an essential role in maintaining healthy and resilient ecosystems in our communities, and birds like the Great Blue Heron remind the public of the importance of continuing to protect a connected Greenway System throughout Richmond Hill.

The Great Blue Heron is characterized by its "S" shaped neck, long legs, and greyishblue upper body. These herons can be found across all of southern Canada. They can be seen standing perfectly still or slowly wading into wetlands and ponds in places like Newberry Park, Richmond Green and Rumble Pond to name just a few. large congregations called 'rookeries', one of which is located in Richmond Hill just to the north of the proposed Heron View Park.

The City's Policy for Naming and Renaming Parks, Open Space and Recreation Facilities indicates that proposed names be advertised with a request for public comments. Staff will advertise on the City of Richmond Hill's website, seeking input from the public. In accordance with the policy, staff will report back to Council regarding any input on the proposed name received during the 30-day commenting period and make a recommendation regarding final approval of the name.

Financial Implications:

There are no financial, staffing or other implications associated with the recommendations of this report.

This park helps to support the 2024 – 2027 Strategic Plan Pillar 1, Growing a Liveable and Sustainable Community, by managing growth in a way that enables choice and connection for the city and its residents now and in the future.
