Background

The park name "Heron View Park" was approved in principle by Council on November 20, 2024 (SRPBS.24.092– see Appendix A) for the planned community park on Bawden Drive (see Map 1 below). In accordance with the City's *Policy for Naming and Renaming Parks, Open Space and Recreation Facilities* (see Appendix B), the proposed name was advertised on the City's website with a request for public comment over a 30-day period ending on January 5, 2025. The 30-day commenting period has


