1. Call to Order

The Mayor called the meeting to order at 9:30 a.m.

Mayor West transferred the Chair to Regional and Local Councillor Chan between 10:15 a.m. and 10:40 a.m. during consideration of Agenda Item 17.1.

2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

3. National Anthem

The National Anthem was played.

4. Public Forum (not exceeding fifteen minutes)

4.1 Cathy Blott, 1765 Haldimand Road 17, Cayuga, regarding the Humber Flats Stormwater Management System

Cathy Blott, professional biologist, 1765 Haldimand Road 17, Cayuga, addressed Council regarding the development of the Humber Flats Stormwater Management System. She raised concerns that proposed changes following an environmental assessment could negatively impact its ecological benefits, emphasized the importance of preserving the site's existing monitoring methods, and the need for collaboration with various stakeholders to protect its future.

4.2 Marie Adams, 520 Sunset Beach Road, and Deborah Weiss, 424 Sunset Beach Road, regarding traffic calming measures on Sunset Beach Road

Marie Adams and Deborah Weiss, residents of Sunset Beach Road, addressed Council to oppose the installation of bollards as traffic calming measures on Sunset Beach Road. They acknowledged the need for traffic control, but indicated bollards were visually unappealing, expensive to maintain, and posed safety risks. They emphasized that local homeowners were opposed to the installation of bollards and urged Council to support their position and prioritize alternative traffic calming measures.

5. Council Announcements

Councillor Cilevitz announced that Saturday, February 15th was observed as National Flag Day in Canada. She shared its history and significance, and encouraged the community to show their support and Canadian pride by wearing red and white.

Councillor Cui announced that on Monday, February 17th, the Chinese community will be celebrating the Spring Festival at Elgin Barrow Arena from 1 p.m. to 5 p.m. He highlighted the planned events, and extended an invitation to the community to join in the festivities.

Councillor Davidson shared her experience attending the King's Coronation Medal Awards last Sunday, acknowledged it was well attended, and extended congratulations to all recipients.

Councillor Thompson reminded everyone that Valentine's Day was two days away and encouraged them to find a way to appreciate a loved one.

Regional and Local Councillor Chan shared that today marked the 15th day of the Lunar New Year, also known as the Lantern Festival, and explained its significance. He extended warm wishes to those celebrating the occasion, and wished everyone a wonderful Valentine's Day on Friday.

Mayor West recognized Richmond Hill's own Jordan Binnington, who will be representing Team Canada as the starting goaltender against Sweden in the 4 Nations Face-off Tournament, and wished him and the team the best of luck in the tournament.

Mayor West acknowledged the many Lunar New Year celebrations he attended, recognized that today marked the end of the festivities, and extended a Happy Lunar New Year to those celebrating.

Mayor West recognized the upcoming Family Day weekend, and encouraged everyone to take the opportunity to celebrate by spending quality time with family and friends.

Mayor West echoed remarks about National Flag Day, encouraged everyone to celebrate and reflect on what makes us Canadian, and to enjoy the occasion.

17.1 Member Motion – Mayor West - "Made in Canada" Procurement Policy

Whereas, the unprecedented and unpredictable nature of American policies have compelled all levels of government to act—including municipalities across Ontario—seeking solutions to protect local, Ontario, and Canadian businesses, to ensure continuity, while minimizing any impact on the public's quality of life if these tariffs are in fact imposed on Canada.

Whereas, the recently imposed U.S. tariffs threaten Canadian goods and economy and to support our local and national economy, it is in the City's best interest to adopt a new procurement approach that prioritizes Canadian-made products, services, and suppliers.

Whereas, prioritizing Canadian-made products, services, and suppliers will protect and create jobs within Richmond Hill, Ontario, and across Canada.

Whereas, the City of Richmond Hill has a responsibility to lead by example in supporting domestic industries while ensuring fiscal responsibility and value for taxpayer dollars.

Whereas, this policy aligns with federal and provincial efforts to support Canadian industries, ensuring a unified approach to economic sustainability in the face of international trade challenges.

Whereas, reducing dependence on foreign suppliers, particularly those affected by unpredictable trade policies, will strengthen local supply chains, and enhance economic resilience for the City of Richmond Hill and its residents.

Now Therefore Be It Resolved:

- Council directs staff to investigate the feasibility of a new "Made in Canada"- Procurement Policy, by identifying the key financial and legal implication of prioritizing Canadian-made goods and services wherever possible and in compliance with applicable trade agreements and legislation.
