By-Law 23-25

A by-law to amend By-law No. 69-16 of the City

Whereas on February 11, 2019, Council of the Corporation of the City of Richmond Hill ("Council") enacted an amendment to The Administrative Penalty By-law No. 69-16 that established an administrative monetary penalty system ("AMPS") for parking infractions, to expand the AMPS system so that it may also apply to promote compliance with any by-law passed pursuant to the Municipal Act, 2001;

And whereas on March 26, 2025 Council of the City adopted the recommendations of Staff Report No. SRCS.25.04 to enact a new by-law for the regulation of the care and keeping of animals in the City (the "Responsible Pet Ownership and Animal Regulation By-law") and to add such by-law as a designated by-law to the Administrative Penalty By-law No. 69-16 so that the Responsible Pet Ownership and Animal Regulation By-law may be enforced using AMPS;

Now Therefore The Council Of The Corporation Of The City Of Richmond Hill Enacts As Follows:

- 1. That Schedule 'A' of the Administrative Penalty By-law No. 69-16 be further amended by adding Table 11 attached to this By-law No. 23-25;
- 2. Except as herein provided and as required to give effect to the amendments in this By-law No. 23-25, the provisions of the Administrative Penalty By-law No. 69-16 continue in full force and effect without amendment.
