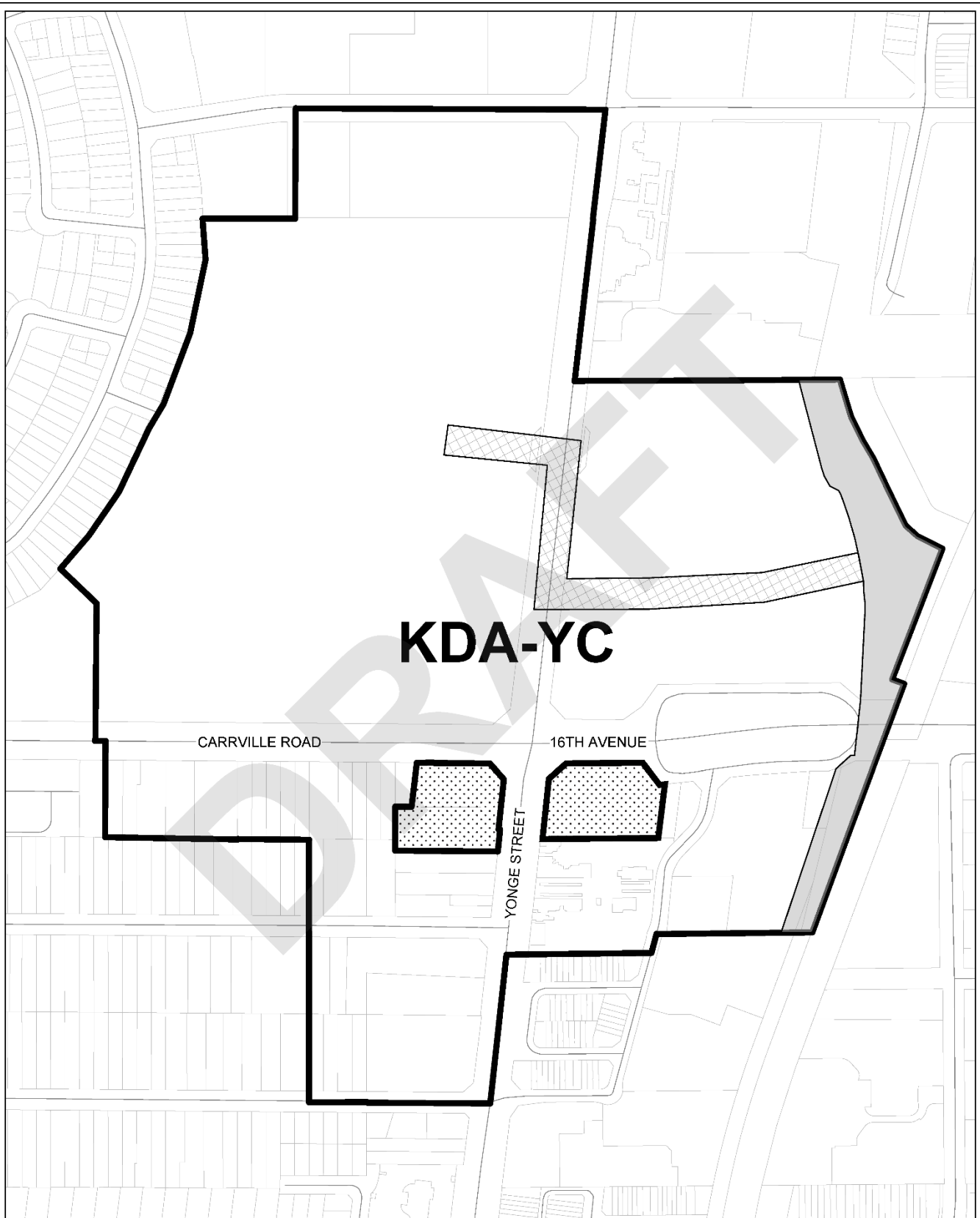
PLANNED LOCAL/COLLECTOR STREETS
