Tony Cicirello, 270 Douglas Road, addressed Committee regarding the proposed Zoning By-law Amendment Application submitted by Arash Azimifar and Zohreh Mirbagheri for 262 Douglas Road. He advised of his concerns with the application as the smaller lot sizes and proposed design would not fit contextually with the existing neighbourhood and would subsequently set a precedent for future development in the area. T. Cicirello further expressed his concerns with potential drainage and flooding issues, environmental impacts and reduced privacy for the existing residents and advised that he would like to see the community preserved.
