6. Scheduled Business

6.1 Presentation by Michael Backs, Manager, Housing Strategic Initiatives, York Region, regarding Updates on York Region's 10-Year Housing and Homelessness Plan

Michael Backs, Manager, Housing Strategic Initiatives, York Region, made introductory remarks regarding the Region's 10-Year Housing and Homelessness Plan (Plan), and outlined the roles and responsibilities of York Region and local municipalities regarding housing and homelessness services. He reviewed the goals within the Plan, progress made in advancing them, and next steps in the development of the next 10-year plan. M. Backs outlined ongoing pressures and challenges affecting housing affordability in York Region, key actions for consideration through the next plan, and concluded with next steps.

There was discussion regarding the Region's ability to purchase low-income units when they become available, highlighting challenges related to funding sources. Questions were raised regarding the strategy for non-profit providers with maturing mortgages, along with a request for details on the housing spectrum that will be included in the next 10-year plan. A suggestion was also made to consider an acquisition program as part of the strategy.

Concerns were expressed about the impact of social housing responsibilities downloaded from the Province, including the Region's inability to collect Development Charges (DC) to fund those obligations. The implications of Bill 23 on lost DC revenues, and the potential taxpayer burden from DC deferrals and property tax discounts proposed in the next plan, were discussed.

6.2 Presentation by Ashley Dickenson, Project Manager - Affordable Housing, regarding Affordable Housing Strategy Action Plan Update

Ashley Dickenson, Project Manager – Affordable Housing, delivered an update on the Affordable Housing Strategy Action Plan. She outlined the

actions that have been completed since 2023, policy and regulatory tools underway, and future actions.

There was discussion regarding the role of Inclusionary Zoning in the Affordable Housing Strategy and its challenges, and a consideration brought forward to expand the role of Housing York as the principal social housing provider, funded by combining Housing Accelerator Funds from the lower tier municipalities. It was emphasized that access to land was the biggest challenge for non-profits, and that ensuring alignment between available land, Community Improvement Plan benefits, and other funding opportunities was critical. The need for consistent definitions across programs and the Official Plan was also emphasized, with caution regarding alignment with the Province's definitions of ownership.
