1. Call to Order

The Mayor called the meeting to order at 9:30 a.m.

2. Land Acknowledgement

We are gathering on lands that have been home to First Nations Peoples from time immemorial. We acknowledge that what we now call Richmond Hill is on the Treaty Lands and Territory of the Mississaugas of the Credit First Nation and the Mississauga and Chippewa Nations of the Williams Treaty. We also recognize that we are on part of the traditional territories of the Haudenosaunee and the Huron Wendat.

We would also like to acknowledge all First Nation, Inuit and Métis peoples from across North America, also known as Turtle Island, who now reside in the City of Richmond Hill. We are committed to rebuilding constructive and cooperative relationships.

3. National Anthem

The National Anthem was played.

4. Public Forum (not exceeding fifteen minutes)

There were no members of the public who addressed Council during the Public Forum.

5. Council Announcements

Councillor Cilevitz advised that Passover will begin at sundown on Saturday, explained the significance of the holiday, and extended warm Passover wishes to everyone celebrating.

Councillor Thompson reminded the community of the upcoming Federal Election, explained that Richmond Hill was divided into two ridings, and noted that the Richmond Hill Board of Trade was hosting two "All Candidates Debate", taking place on April 15 at the Oak Ridges Community Centre at 6:30 p.m., and on April 16 at the Bayview Hill Community Centre at 6:30 p.m.

Councillor Cui acknowledged that April 2nd was Autism Awareness Day, and noted that there were various initiatives to raise awareness, organized by different charity teams held in Richmond Hill and other cities.

Mayor West reported on the successful trade mission held in Germany, highlighting that Canada was the featured Country at the Hannover Messe trade show. He advised that the mission included many productive meetings and discussions, thanked staff for their support and leadership in organizing the trip, and looked forward to positive outcomes from the mission.

Mayor West announced that today marked the International Day of Pink, highlighted its importance in promoting inclusivity and diversity, and standing against bullying and discrimination.

Mayor West echoed Councillor Cui's remarks, recognizing April as Autism Awareness Month, and highlighted that a flag raising event was held at the municipal offices earlier this morning. He also acknowledged members of Autism Ontario in attendance, noting their presence was a meaningful way to raise awareness of the contributions individuals with autism make to the community.

Mayor West echoed remarks by Councillor Cilevitz and extended warm wishes to those observing Passover.

Mayor West acknowledged the Richmond Hill Coyotes Hockey Team had won their first-ever championship in the Central Ontario Super Hockey League (COSHL), and extended congratulations to the team. Mayor West advised that the annual Maple Syrup Festival will be held this Saturday at Richmond Green Sports Centre and Park from 10 a.m. to 4 p.m. and invited the community to join in on the many planned activities.

13.1 Presentation by Candice Debi, Director, Communications Services, to Mayor West and Members of Council regarding 3 MarComm, 1 Viddy, and 11 AVA communications and marketing awards awarded to the City of Richmond Hill – (refer to the Agenda for a complete list of awards)

Mayor West announced the various communications and marketing awards the City had received, and expressed his appreciation to the Communications staff for their dedication and hard work.

Candice Debi, Director, Communication Services, made a presentation to Members of Council announcing that the City had been honoured with 15 awards for excellence in communications, recognizing efforts to keep the community informed, engaged and connected. She noted that the awards spanned over a two-year period, celebrated the City's achievements, and highlighted the creativity, innovation, and dedication involved in delivering high-quality services to residents. C. Debi commended Communications staff for their talent and strong commitment to public service, and expressed gratitude to Members of Council for their ongoing support, leadership, and for fostering an environment where excellence can thrive.

Kathrine Mabley, 300 Douglas Road, addressed Council regarding the proposed application submitted by Arash Azimifar and Zohreh Mirbagheri for 262 Douglas Road. She raised concerns with a proposed land severance near Lake Wilcox, and shared her experience with a past pumping station failure causing sewage to flood her basement. She further expressed concerns with environmental impacts, including runoff into the lake and loss of wildlife. She indicated that she was not opposed to development but emphasized the need for responsible and respectful development. K. Mabley, on behalf of 10 Joyces Point residents, requested Council address three key concerns: drainage risk, environmental impact, and City liability, and urged Council to consider the environmental, infrastructure, and community implications before approving the severance.
