A By-Law to amend By-law 69-16 of the City of Richmond Hill

Whereas on February 11, 2019, Council of the Corporation of the City of Richmond Hill ("Council") enacted an amendment to the Administrative Monetary Penalty By-law 69-16 that established an Administrative Monetary Penalty System ("AMPS") for parking infractions, to expand AMPS so that it may also apply to promote compliance with any by-law passed pursuant to the *Municipal Act, 2001;*

And Whereas on April 23, 2025 Council of the City adopted the recommendations of Staff Report SRPBS.25.025 to enact a new by-law for the regulation of Trees on City Lands (the "Trees on City Lands By-law") and to add such by-law as a designated by-law to By-law 69-16 so that the Trees on City Lands By-law By-law may be enforced using AMPS;

Now Therefore The Council Of The Corporation Of The City Of Richmond Hill Enacts As Follows:

- 1. That Schedule 'A' of By-law 69-16 of the Corporation of the City of Richmond Hill, as amended, be further amended by adding Table 14 attached to this By-law 49-25;
- 2. Except as herein provided and as required to give effect to the amendments in this By-law 49-25, the provisions of By-law 69-16 continue in full force and effect without amendment.
