#### 1. Call to Order

The Chair called the meeting to order at 9:30 a.m.

Councillor Liu transferred the Chair to Councillor Thompson between 10:30 a.m. to 10:40 a.m.

Council consented to recess the meeting between 11:50 a.m. and 12:50 p.m.

#### 2. Council Announcements

Mayor West advised that April 13 to 19 was recognized as National Public Safety Telecommunicators Week. He acknowledged the hard work, professionalism, and dedication of individuals serving in these roles, including staff at Richmond Hill Fire and Emergency Services, and, on behalf of Members of Council, extended his gratitude to each of them for their service.

Councillor Cui noted that April 15<sup>th</sup> marked the beginning of the 2025 yard waste collection schedule for residents in Richmond Hill.

Councillor Cui advised that the City was currently hiring additional crossing guards to help keep school areas and the community safe, and encouraged those interested to apply.

Councillor Cui advised that Richmond Hill's "Clean Up, Green Up Weeks" would begin next week and encouraged volunteers to sign up to help pick up litter in various parks. For those unable to attend on the scheduled dates, he suggested that volunteers could clean up an area on their own.

Mayor West extended his appreciation to staff from his Office and Public Works Operations for their assistance in organizing a successful Maple Syrup Festival held over the past weekend. He noted that the event was well-attended and provided residents with an opportunity to learn more about their community and engage with their neighbours.

Regional and Local Councillor Chan advised that April 7 to 11 was Canadian Public Health Week and shared that he was able to have discussions with the Acting Medical Officer of Health for York Region regarding the various services they deliver to the community, noted the increased numbers of infectious disease incidents, and acknowledged the hard work of public health professionals.

Regional and Local Councillor Chan advised that this past Monday he attended the class of 2024 York Region Paramedic Services graduation ceremony, highlighted that 2025 marked the 25<sup>th</sup> anniversary of the establishment of York Region Paramedic Services, and acknowledged their service to the residents of Richmond Hill.

### 9. Presentation(s)

### 9.1 Presentation by Darlene Joslin, City Manager, and Anthony Iannucci, Chief Transformation Officer, regarding Richmond Hill's Continuous Improvement Journey

Darlene Joslin, City Manager, provided introductory remarks regarding the City's Continuous Improvement (CI) journey, noting the City's commitment to continued learning and fostering a culture of excellence, where staff are empowered to find creative solutions to improve efficiencies. She advised that the City is at the beginning of the CI journey, and introduced Anthony lannucci, Chief Transformation Officer to speak further on the CI program and the successes they have achieved.

A. Iannucci provided an overview and history of Richmond Hill's CI program, beginning with the adoption of the Lean methodology in 2018, and explained the principles of the Lean program. He advised that the pandemic in 2020 accelerated the need for service digitization and process improvements, leading to the development of a service catalogue and performance-based culture. He advised that the City introduced an Organization Management Framework, and outlined the improvement methodology in place. He also reviewed the CI Development Program, detailing its projects, and the value generated through cost and time savings, as well as other intangible benefits. A. Iannucci concluded by outlining how the City's CI program will evolve in 2025 and in the future.

### 10. Delegation(s)

### 10.1 Sarah Duncan, Forbes Bros. Ltd., on behalf of Rogers, regarding Radio-Communication and Broadcasting Antenna (refer to Item 11.10)

Sarah Duncan, Forbes Bros. Ltd., on behalf of Rogers, addressed Committee regarding the proposed Radio-Communication and Broadcasting Antenna located at 120 West Beaver Creek Road. She outlined the existing network infrastructure and emphasized the need to enhance coverage to better serve the Doncrest neighbourhood. She reviewed the proposed site location and antenna design, community feedback received during public consultation, and presented photo renderings of the proposed installation. She also provided follow-up information in response to the September 18, 2024 Committee of the Whole meeting, at which Rogers was requested to explore alternative site locations. In conclusion, she requested that Council support staff's recommendation as outlined in the associated staff report.

### 10.2 Justin Tse, 42 Red Oak Drive, regarding Radio-Communication and Broadcasting Antenna - (refer to Item 11.10)

Justin Tse, 42 Red Oak Drive, addressed Committee regarding the proposed Radio-Communication and Broadcasting Antenna located at 120

West Beaver Creek Road. He urged Council not to support the proposed antenna, expressing concerns about its potential impact on property values, health risks to the community, and the well-being of children attending the Doncrest Public School. He also questioned the need for an antenna as the community did not ask for improved coverage.

### 10.3 Donna Chan, 23 Teseo Court, regarding Radio-Communication and Broadcasting Antenna - (refer to Item 11.10)

Donna Chan, of 23 Teseo Court, addressed the Committee regarding the proposed Radio-Communication and Broadcasting Antenna at 120 West Beaver Creek Road. She asked Council not to support the recommendations outlined in the associated staff report. D. Chan questioned the claim of a gap in network coverage and expressed concern that the installation of the antenna would significantly expose Doncrest Public School to microwave wireless radiation, potentially posing health risks. She also inquired whether Council and the City would assume the risk of litigation should the proposal be approved. Additionally, she raised concerns about the antenna's impact on the streetscape and property values, and questioned the accuracy of the renderings of the antenna provided by Rogers.

### 10.4 Joyce Fox, 73 Angelica Avenue, regarding Radio-Communication and Broadcasting Antenna - (refer to Item 11.10)

Joyce Fox, 73 Angelica Avenue, addressed Committee regarding the proposed Radio-Communication and Broadcasting Antenna located at 120 West Beaver Creek Road. She noted the lack of support in the community for the antenna, commented on the role of Innovation, Science and Economic Development Canada (ISED), raised concerns about whether the applicant fully complied with the City's submission and public consultation requirements, and disagreed with staff's conclusion that the proposed antenna would not impact the streetscape. She voiced concerns about the antenna's proximity to residential homes and Doncrest Public School, citing evidence suggesting potential health risks. She questioned the necessity of the antenna, referenced examples of other Ontario municipalities that have rejected similar proposals, and urged Council not to support the installation of the antenna.

### 10.5 Rula Zabeneh, on behalf of Safety for Cell Towers Richmond Hill, regarding Radio-Communication and Broadcasting Antenna - (refer to Item 11.10)

Rula Zabeneh, on behalf of Safety for Cell Towers Richmond Hill, addressed Committee regarding the proposed Radio-Communication and Broadcasting Antenna located at 120 West Beaver Creek Road. She explained the respective roles of Innovation, Science and Economic Development Canada (ISED) and the City in the antenna approval process, noting that ISED does not formally authorize antenna installations. She advised that the responsibility to issue a letter of concurrence, which constitutes approval of the proposal, lies with the Land Use Authority. Referencing feedback from ISED, R. Zabeneh explained that the City may oppose the proposal by issuing a letter of nonconcurrence should they have concerns relating to the full completion of the protocol process. She concluded by asking Council to not support the installation of the antenna.

# 10.6 Margaret Friesen, on behalf of Canadians for Safe Technology, regarding Radio-Communication and Broadcasting Antenna - (refer to Item 11.10)

Margaret Friesen, speaking on behalf of Canadians for Safe Technology, addressed the Committee regarding the proposed Radio-Communication and Broadcasting Antenna at 120 West Beaver Creek Road. She spoke about her educational background, professional experience, and extensive involvement with issues related to cell towers. M. Friesen cited examples of Ontario municipalities that have voted non-concurrence on similar proposals, and highlighted deficiencies in the public consultation process conducted by Forbes Bros. She concluded by urging Council to stand with Doncrest residents and local commercial tenants by not supporting the application for the proposed antenna.

#### 12. Other Business

### 12.1 Member Motion - Councillor Cilevitz - Provincial regulations needed to restrict keeping of non-native ("exotic") wild animals

Moved by: Councillor Cilevitz

Whereas Ontario has more private non-native ("exotic") wild animal keepers, roadside zoos, mobile zoos, wildlife exhibits and other captive wildlife operations than any other province; and,

Whereas the Province of Ontario has of yet not developed regulations to prohibit or restrict animal possession, breeding, or use of non-native ("exotic") wild animals in captivity; and,

Whereas non-native ("exotic") wild animals can pose very serious human health and safety risks, and attacks causing human injury and death have occurred in the province; and,

Whereas the keeping of non-native ("exotic") wild animals can cause poor animal welfare and suffering, and poses risks to local environments and wildlife; and,

Whereas owners of non-native ("exotic") wild animals can move from one community to another even after their operations have been shut down due to animal welfare or public health and safety concerns; and,

Whereas municipalities have struggled, often for months or years, to deal with non- native ("exotic") wild animal issues and have experienced substantive regulatory, administrative, enforcement and financial challenges; and,

Whereas the Association of Municipalities of Ontario (AMO), the Association of Municipal Managers, Clerks and Treasurers of Ontario (AMCTO) and the Municipal Law Enforcement Officers' Association (MLEOA) have indicated their support for World Animal Protection's campaign for provincial regulations of non-native ("exotic") wild animals and roadside zoos in letters to the Ontario Solicitor General and Ontario Minister for Natural Resources and Forestry;

#### Now Therefore Be It Resolved:

- 1. That the City of Richmond Hill hereby petitions the provincial government to implement provincial regulations to restrict the possession, breeding, and use of non-native ("exotic") wild animals and license zoos in order to guarantee the fair and consistent application of policy throughout Ontario for the safety of Ontario's citizens and the non-native ("exotic") wild animal population;
- That this resolution will be forwarded to all municipalities in Ontario for support and that each endorsement be then forwarded to the Premier of Ontario, Ontario Solicitor General, Ontario Minister for Natural Resources and Forestry, and Richmond Hill MPP's, AMO, AMCTO, and MLEOA.
