

# The Corporation of the City of Richmond Hill

## By-Law 65-25

A By-law to amend Chapter 1116 of the City of Richmond Hill Municipal Code, being By-law 402-89, as amended, relating to parking regulation

Whereas on November 6<sup>th</sup>, 1989, the Corporation of the City of Richmond Hill (the “City” enacted by by-law No. 402-89 that regulates the parking of motor vehicles on public highways and other property (“Parking Regulation By-law”).

**Now Therefore The Council Of The Corporation Of The City Of Richmond Hill Enacts As Follows:**

1. That Schedule ‘A’ – Parking Prohibited – Permit Required, in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by deleting the following rows in alphabetical order.

Bayview Park Lane	Both	Bayview Avenue to Sunset Beach Road	Anytime
Park Crescent	Both	Sandbanks Drive to West Limit of Sunset Beach Road	Anytime

2. That Schedule ‘A’ – Parking Prohibited – Signs – Displayed in Chapter 1116, being By-law No. 402-89 of the Corporation of the City of Richmond Hill (the “Parking Regulation By-law”), be amended by inserting the following rows in alphabetical order:
