#### 4. Scheduled Business:

4.1 SRPBS.25.070 - Request for Comments - Comprehensive Zoning Bylaw Project (Neighbourhood, including the North Leslie Secondary Plan and West Gormley Secondary Plan Areas, Employment Lands, Greenway System, Leslie Street Institutional Area, and Utility Corridor) - City of Richmond Hill - City File MZBA-23-0001

Salvatore Aiello, Manager, Development Zoning, of the Planning and Building Services Department, provided an overview of the proposed amendment to the Comprehensive Zoning By-law (CZBL) for the City of Richmond Hill with respect to the City's Neighbourhood, including the North Leslie Secondary Plan and West Gormley Secondary Plan Areas, Employment Lands, Greenway System, Leslie Street Institutional Area, and Utility Corridor. He provided an overview of the applicable legislative and planning policy regime for the draft CZBL framework and reviewed key elements of interest within the draft CZBL including framework, zone categories and zones. S. Aiello concluded the presentation by providing an interactive zoning schedule demonstration.

Michael Theodores, 481 Major Mackenzie Drive East, addressed Council regarding the proposed amendment to the Comprehensive Zoning By-law (CZBL) for the City of Richmond Hill. He inquired as to why his correspondence from February 2025 was included as part of the agenda, and provided comments regarding the CZBL specific to his concerns with transit and Richmond Hill GO service for residents within Richmond Hill. M. Theodores stressed the importance of advocating and taking transit into consideration when development proposals are being reviewed to create a shared experience.

Mark Resnick, BAIF Developments Limited, addressed Council regarding the proposed amendment to the Comprehensive Zoning By-law (CZBL) for the City of Richmond Hill. He provided comments specific to how the CZBL would impact their property located at 13515 and 13715 Yonge Street and 53 St. Laurent Drive which was proposed for residential use and would result in non-compliance under the CZBL, requesting that it be excluded from the new by-law. He further provided comments specific to how the CZBL would impact their property located at 305 Stouffville Road which was also proposed for residential use, requesting that the proposed CZBL be amended to maintain the current development permissions. M. Resnick concluded by sharing their concerns regarding the impact of the CZBL on employment lands as the new by-law eliminated commercial, retail and office uses from the list of permitted uses unless the use existed on October 24, 2024.
