### **Background:**

#### **Discussion:**

The City is now in a position to bring forward a consolidated version of the Comprehensive Zoning by-law for the entirety of the City, inclusive of the Richmond Hill Centre. In order to meet the City's statutory requirements under the *Planning Act* as well as the timelines for City's Housing Accelerator Fund commitments, a final statutory Council Public Meeting by the end of September 2025 is required to be held prior to the enactment of the by-law. It is noted that the associated statutory Open House will be held in August 2025.

## Recommendation(s):

- a) That the Memorandum from Gus Galanis, Commissioner of Planning and Building Services, dated July 3, 2025, regarding a Request for Additional Council Public Meeting on September 2, 2025, be received;
- b) That an additional Council Public Meeting, pursuant to Article 8 of the Procedure By-law 125-23, as amended, be scheduled for 6:00 p.m. on September 2, 2025, for the purpose of the consideration of the City's Comprehensive Zoning By-law.
