

The Corporation of the City of Richmond Hill

By-Law 100-25

A By-Law to amend Schedule “A”, as amended, being Chapter 1126 of the City of Richmond Hill Municipal Code, relating to the Speed of Motor Vehicles.

Whereas Section 128 (2.1) of the Highway Traffic Act, R.S.O. 1990, C. H.8 (the “HTA”) provides that the council of a municipality may prescribe a rate of speed different from the rate set out in Section 128 (1) of the HTA for motor vehicles driven on a highway, or portion thereof, under its jurisdiction.

And Whereas Council at its meeting of November 26th, 2025, adopted the recommendation in SRIES.25.011 to reduce the maximum speed limit on the roads noted below to 40 kilometers per hour;

Now Therefore The Council Of The Corporation Of The City Of Richmond Hill Enacts As Follows:

1. That, notwithstanding the general provisions of the Highway Traffic Act, R.S.O. 1990, Chapter H.8, Schedule “A” in Chapter 1126 of the City of Richmond Hill’s Municipal Code be amended by deleting the following roads:

Schedule ‘A’ - Speed limits

| Street | From | To |

| Humberland Drive | Red Cardinal Trail | Coons Road |
| Red Maple Road | High Tech Boulevard | a point 150 m (493 ft.) north of Bantry Avenue |
| Redstone Road | a point 150 m (493 ft.) southwest of Princeton Avenue | a point 150 m (493 ft.) north of Toporowski Drive |
| Trench Street | Major Mackenzie Drive West | 152.4 m (500 ft.) north of north boundary line of Alexander Mackenzie Secondary School |
| Weldrick Road West | Walmer Road | Springhead Gardens |

2. That, notwithstanding the general provisions of the Highway Traffic Act, R.S.O. 1990, Chapter H.8, Schedule “A” in Chapter 1126 of the City of Richmond Hill’s Municipal Code be amended by inserting the following roads:
